Respondents are identical in this case and in the cases listed *supra*. All six cases concern the same dispositive legal issue; i.e., each challenges Respondents' use of mandatory detention pursuant to 8 U.S.C. § 1225(b)(2)(A) against noncitizens who entered the United States without inspection years ago. Moreover, Petitioner's counsel here is also one of Petitioner-Plaintiff's counsels in *Mendoza Gutierrez* and the same counsel as Petitioner-Plaintiff in *Moya Pineda*, *Hernandez Vazquez*, *Domingo Campos*, *Nava Hernandez*, and *Loa Caballero*. Here, Mr. Ortiz raises the same dispositive issue as in all six cases is Respondents' use of mandatory detention in § 1225(b)(2)(A).

The cases are therefore related.
