JOINT STATUS REPORT AND
STIPULATED PROPOSED BRIEFING
SCHEDULE

On October 31, 2025, Dkt. 5, the Court granted a Temporary Restraining Order prohibiting the petitioner's removal from the United States or from this jurisdiction pending further order of the court. Since then, the parties have completed briefing for the TRO. In addition, other judges have granted similar TROs for Ms. Tzafir's mother, Marina Tzafir, 2:25-cv-02067-JHC-SKV, and father, Binyamin Tzafir, 2:25-cv-02126-JHC.

To bring all three cases into procedural alignment, the parties propose that the petitioner submit her motion for a preliminary injunction by November 18, 2025. The respondents will file their response by November 21, 2025. The petitioner will submit a reply, if any, by November 25, 2025. Neither party seeks oral argument on the motion for preliminary injunction.
