**PETITIONER'S MOTION FOR ISSUANCE OF ORDER TO SHOW
CAUSE PURSUANT TO 28 U.S.C. § 2243**

COMES NOW the Petitioner, Lilian Roxana Vallejo, by and through undersigned counsel and hereby files the instant Motion for Issuance of Order to Show Cause and respectfully states as follows:

1. The Petitioner incorporates by reference the facts and procedural history as set forth in the Verified Petition for a Writ of Habeas Corpus Pursuant to 28 U.S.C. § 2241 and Complaint for Declaratory and Injunctive Relief. *See* ECF No. [1], at ¶¶16-32.

2. In the Petition and Complaint, the Petitioner argued that the Respondents have violated the Petitioner's Due Process rights under the Fifth Amendment of the U.S. Constitution. *See* ECF No. [1], at ¶¶85-94.

3. Moreover, the Petitioner argued that the Respondents violated the Administrative Procedure Act ("APA") by failing to follow their own regulations and policies related to revocation of parole and bond. *See* ECF No. [1], at ¶¶95-98.

4. The Petitioner respectfully requests that this Honorable Court "forthwith" issue an Order directing the Respondents to show cause why this Honorable Court should not grant the Petition for a Writ of Habeas Corpus. *See* 28 U.S.C. § 2243.

5. "A court, justice or judge entering a writ of habeas corpus shall forthwith award the writ or issue an order directing the respondent to show cause why the writ should not be granted, unless it appears from the application that the applicant or person detained is not entitled thereto." *Id.*

6. The writ or order to show cause "shall be returned within three days unless for good cause additional time, not exceeding twenty days, is allowed." *Id.*

7. The Court shall hold a hearing on the writ or order to show cause "not more than five days after the return unless for good cause additional time is allowed." *Id.*

8. The Court "shall summarily hear and determine the facts, and dispose of the matter as law and justice require." *Id.*

9. Accordingly, the Petitioner respectfully requests that the Court issue an Order to Show Cause directing the Respondents to file a return within three days of the Court's order, showing cause, if any, why the Court should not grant the writ of habeas corpus, and to provide the Petitioner an opportunity to file a reply (traverse) within three days after the Respondents file the return.

10. Providing additional time to the Respondents to file a return is inappropriate in this case because the Petitioner faces irreparable harm to deprivation of physical liberty and continued detention at the Respondents' detention facility, causing her to remain separated from her minor U.S. citizen child. *See* ECF No. [1], at ¶¶22-25 (showing Respondents have detained the Petitioner since June 26, 2025, thus separating her from her minor U.S. citizen child).

11. The Petitioner has attached a Proposed Order to this Motion.
