

**PETITION FOR A WRIT OF
HABEAS CORPUS
(Southern District of California)**

Petitioner hereby respectfully submits a Petition For Writ of Habeas Corpus pursuant to 28 U.S.C. Sub.Sec. 2241 and states as follows:

1. Wang currently being held on Federal Authorities by U.S Immigration and Customs Enforcement, (ICE), at the Otay Mesa Detention Center in San Diego, California.
2. Petitioner's immigration identification number is A [REDACTED]
3. ICE arrested Petitioner on March 20, 2025 when Petitioner was at work without reason.
4. Wang is being held on immigration Final Order of Deportation pending ICE obtain

travel documents for Petitioner to deport to China.

5. Petitioner is challenging the decision of ICE to arrest, release and re-detain Petitioner.
6. ICE violated 8 C.F.R. Sub.Sec. 241.13 (I) (2) which denied Petitioner of informal hearing.
7. ICE violated INA 241 (a) which denied petitioner 90 days review.
8. ICE violated 8 U.S.C Sub.Sec 1231(a)(6) which detaining Petitioner beyond removal period authorized by statute and not a likely to remove Petitioner in the near future.
9. ICE violated the due process clause of the Fifth Amendment to the U.S. Constitution by prolonged detain Petitioner in which deprives Petitioner's right to liberty.
10. Petitioner was released in 2019 on an Order of Supervision. See Attached document. Tadros v. Noem.
11. Petitioner was re-detained under no changed circumstances. Nguyen v. Hyde.

CONCLUSION

Petitioner has been released and re-detained by ICE under no changed circumstances. His supervision was suddenly revoked without any prior notice and because ICE has failed to show any changed circumstances, Petitioner moves to ask this Honorable Court for a grant of release from the custody of Department of Homeland Security/Immigration and Customs Enforcement.
