**STIPULATION TO SEVER PETITIONERS INTO SEPARATE CASES**

Petitioners, and Respondents, through undersigned counsel, hereby stipulate and agree as follows:

1. The above-captioned habeas corpus petition was filed on behalf of three Petitioners — JUAN TEJADA POLANCO, FREDDY QUIZHPI SIBRI, and RONY PINEDA — who are presently detained at the Donald W. Wyatt Detention Facility in Central Falls, Rhode Island.

2. The parties agree that the claims shall be severed in this matter, one for each Petitioner.

3. Each severed case shall proceed independently under a new civil docket number assigned by the Clerk, and each Petitioner's existing pleadings shall be deemed filed in their respective individual case. The parties request that the Court issue a new individual response date for each petition after each petition is docketed

4. The caption of each new case shall be amended to reflect the individual Petitioner's name and the same Respondents as in the original filing.

5. The stay order entered in this case on October 23, 2025, shall remain in full force and effect in each individual civil action.

6. Nothing in this stipulation shall be construed as a waiver of any claim, defense, or objection by any party.
