**JOINT STIPULATION TO VACATE  
THE HEARING SCHEDULED FOR  
DECEMBER 2, 2025, AND TO ISSUE  
A FINAL ORDER BASED ON THE  
TENTATIVE RULING**

On November 25, 2025, this Court issued a tentative ruling in advance of the hearing scheduled for December 2, 2025. Doc. 12 at 10. The Court further stated that if the parties jointly agree, after reviewing the tentative ruling, that the hearing is unnecessary, they may file a stipulation to vacate the hearing and issue a final order based on the tentative ruling. Counsel for Petitioner and Respondents conferred on November 26 and November 28, 2025, and hereby jointly stipulate and agree as follows:

- 1) Petitioner Quoc Huy Nguyen filed a Petition for Writ of Habeas Corpus and a motion for injunctive relief, both challenging his immigration detention. (Docs. 1, 2.).

- 1 2) In this Court's October 31, 2025, order, the Court ordered Respondents to file an
- 2 expedited response to the TRO motion. (Doc. 5.)
- 3 3) The motion is now fully briefed. (Docs. 7, 9.)
- 4 4) The Court may issue a final order. (Doc. 12).
- 5 5) The Court may vacate the December 2, 2025, hearing.
