Petitioner Eraldo Sibó Aguilar and Respondents hereby stipulate that this action be dismissed without prejudice as to all claims, causes of action, and parties, with each bearing their own attorney's fees and costs, pursuant to Federal Rule of Civil Procedure 41(a)(1)(A)(ii).

Mr. Sibó Aguilar filed the instant habeas petition on November 10, 2025. The Court then issued an order for return and status report, and the Respondents filed a return memorandum and declaration opposing the relief sought by the petitioner.

On December 10, 2025, however, the Petitioner sought and was granted pre-conclusion voluntary departure by the Immigration Judge overseeing his removal proceedings. Accordingly, Petitioner has agreed to depart the United States on or before January 9, 2025. Accordingly, he has now agreed to dismiss the instant habeas petition. The dismissal of this action shall be effective upon the filing of this notice.
