JOINT MOTION TO STAY PROCEEDINGS

COMES NOW Petitioner, CESAR AUGUSTO MARTINEZ MONCADA, by and through the undersigned counsel, and Defendants KRISTI NOEM, *et al.*, by and through the undersigned Assistant United States Attorney, upon conferral pursuant to Local Rule 7.1, respectfully requests the Court stay this proceeding for fourteen (14) days, and in support thereof states as follows:

1. On November 12, 2025, Counsel filed Petitioner's Application/Petition for Writ of Habeas Corpus (hereinafter "the Petition") pursuant to 28 U.S.C. § 2241. [ECF No. 1].
2. On November 17, 2025, this Court entered an Order to Show Cause requiring a response to be filed on or before November 24, 2025. [ECF No. 4].

3. On November 18, 2025, Respondents Counsel, Assistant United States Attorney H. Ron Davidson, conferred with Plaintiff's counsel on certain facts ascertained in the Petition. Specifically, Mr. Davidson correctly pointed out that Petitioner was never detained in Alligator Alcatraz and that Petitioner was in fact issued an order of expedited removal in 2021.
4. The undersigned had relied in good faith on statements from Petitioner and his family when asserting that Petitioner had been detained at "Alligator Alcatraz" and had not been issued an order of expedited removal.
5. The above-referenced facts are material to the allegations presented in the Petition.
6. At this time, Plaintiff and undersigned have not been able to meet and confer with the Petitioner.
7. Accordingly, the undersigned requires additional time to confer with Petitioner who remains detained to verify the facts and determine how to proceed in amending the Petition.

Therefore, the Parties jointly and respectfully request that the Court stay the proceedings including this Court's Order to Show Cause for fourteen (14) days to allow counsel sufficient time to investigate the clarified facts and submit an amended Petition or otherwise advise the Court on how Petitioner intends to proceed.
