**Respondents' Second Status Report**

The Respondents provide this second status report in response to the Court's November 24 order granting Petitioner Miguel Hernandez's Motion for Temporary Restraining Order and Preliminary Injunctive Relief and Request for an Immediate Hearing, [[Dkt. 10](#)] (the "Order").

1. Respondents acknowledge receipt of the Order.
2. Respondents submit that a bond hearing for the Petitioner was held November 26, at 8:30 AM eastern standard time.

3. The presiding immigration judge granted Petitioner Hernandez bond.
4. On November 26, 2025, Petitioner paid bond using U.S. Immigration and Customs Enforcement's ("ICE") CeBonds computer system.
5. The CeBonds system accepts payments for ICE bonds. It also uses a multistep review process before approving the resulting bond contract with the relevant obligor. The review process includes verification of the obligor's citizenship through review of the identification provided by the obligor, verification of the obligor's address, review of the wire transfer payment, and other review processes before final approval of the bond contract.
6. Petitioner Hernandez's bond contract is currently undergoing the review process described in paragraph five (5) above.
