On November 19, 2025, this Honorable Court issued an Order to Show Cause requesting clarification of Petitioner's place of detention. ECF No. 4, PageID.85.

Undersigned counsel respectfully submits that Petitioner has been detained by Immigration and Customs Enforcement at the Monroe County Jail since he was

picked up on October 25, 2025. The mention of North Lake Correctional Center in the supporting brief was an inadvertent clerical error.
