Lyons, Acting Director of Immigration and Customs Enforcement, and Miguel Vergara, San Antonio Field Office Director, Respondents, by and through the United States Attorney for the Western District of Texas and hereby file their Joint Status Report confirming that Enma Jamileth Tinoco Pineda has been released:

1) On December 2, 2025, the Court ordered 1) Respondents to release Petitioner Enma Jamileth Tinoco Pineda (“Tinoco Pineda”) from custody by no later than 12:00 p.m. on December 3, 2025, under appropriate conditions of release; 2) Respondents to notify Tinoco Pineda’s counsel of the exact location and time of Petitioner’s release as soon as practicable and no less than two hours before her release; 3) and ordered parties to file a Joint Status Report no later than 5:00 p.m. on December 4, 2025, confirming that Tinoco Pineda has been released.

2) Petitioner Tinoco Pineda was released on Order of Supervision from the Karnes County Immigration Processing Center on December 2, 2025. Petitioner’s counsels were advised of the time and location of Petitioner’s release.
