EMERGENCY SUPPLEMENT TO PETITION FOR WRIT OF HABEAS CORPUS

At approximately 8 a.m. this morning, agents of ICE ERO re-detained the Petitioner, Jean Dupont, placed him in handcuffs, and indicated they are driving him to Massachusetts. The Petitioner hereby: (1) seeks enforcement of the Court’s order releasing Mr. Dupont from detention under Count I of his Petition for a Writ of Habeas Corpus (the “Petition”); (2) and refiles and restates Counts II and III of his Petition, based on the new information that he has been re-detained without notifying Petitioner’s Counsel, Respondents’ Counsel, or the Court. The Petitioner incorporates as included herein the facts provided in the original verified Petition and the other facts and evidence adduced during these proceedings.

Undersigned counsel files this on an emergency basis based on information that Mr. Dupont is currently en route to the Maine-New Hampshire border and will supplement this filing later in the day.
