1. On December 18th, 2025, a Redetermination of Custody Status Hearing was held before Immigration Judge M. Garcia.
2. The petitioner, Mr. KEHMESS was represented by Attorney Veronica Cardenas.
3. The Department of Homeland Security was represented as well.
4. The Immigration Judge after hearing arguments from the attorneys denied bond. *See* Exhibit 1- Bond Order
 - a. “The Court finds the Respondent is a flight risk. Respondent is a recent entrant and has not demonstrated significant ties to the United States. Additionally, the record does not demonstrate the likelihood of success on relief sought by the Respondent.”
5. The Department of Homeland Security, waived appeal.
6. Mr. Kehmess reserved his right to appeal.
7. The hearing was then adjourned and the parties were excused.
