MOTION FOR RECONSIDERATION

17 Respondent respectfully moves for reconsideration of the Court's December 21, 2025 Order
18 granting Petitioner's motion for a preliminary injunction. Reconsideration is warranted because the
19 Court's ruling rested on an incomplete factual record, due to counsel's mistaken belief that the
20 parole-violation log had been attached to Respondent's response to the Order to Show Cause. These are
21 not new facts and not newly discovered evidence; rather, they are facts that existed at the time of
22 briefing but were inadvertently omitted from the materials before the Court. Correcting that omission is
23 necessary to prevent clear error and manifest injustice.
