Request for Review of Continued Detention after final Order of removal

Dear Judge,

My name is Mykhailo Pylypiv, a citizen of Ukraine and the husband of Iryna Pylypiv, who is currently detained by U.S. Immigration and Customs Enforcement (ICE) at the South Louisiana ICE Processing Center in Basile, Louisiana. An immigration judge issued a final order of removal against my wife on May 29, 2025, and as of today, approximately 160-170 days have passed since that decision. She remains detained without indication of removal in the near future. Under the Supreme Court decision in *Zadvydas v. Davis*(533 U.S. 678, 2001), ICE may not continue to detain an individual beyond six months after a final order of removal unless there is a significant likelihood of removal in the reasonably foreseeable future. My wife has not refused to cooperate with ICE and has no access to assistance from the Ukrainian Consulate, yet she continues to be detained/ She is fully willing to comply with all releace conditions and doesn't pose any risk to the community. I respectfully ask the Court to review her prolonged detention, and direct ICE to release her under supervision, as permitted by U.S. Law and due process principles. Thank you for your time, fairness, ad commitment to justice.
