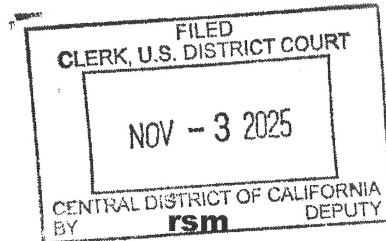

I. INTRODUCTION

Petitioner, Alidad Alibaba Ahadpour, seeks Habeas Corpus relief from this Court pursuant to 28 U.S.C. § 2241. Petitioner is filing *pro se*.

Petitioner is challenging the legality of Immigration and Custom Enforcement (ICE) revocation of my Order of Supervision (OSUP) outlined in 8 CPR §241.4(l)(2) and 8 CFR §241.13(i) and ICE's violation of the Fifth Amendment Due Process clause.

Petitioner was born in Tehran, Iran and is an Iranian Citizen but has no legal status or birth certificate proving such status. Petitioner has attempted to acquire proof from the Iranian Consulate but to no avail.

II. BACKGROUND

In October of 2018 Petitioner was sent to ICE after serving his prison term. After seven months in ICE detention Petitioner lost his immigration case and was ordered deported. ICE failed to acquire travel documents from Petitioner's country of origin and was released by Order Of Supervision (OSUP) in May of 2019.

Petitioner complied with ICE orders and was put on an ankle monitoring system and checked in weekly. Petitioner even assisted with obtaining travel documents by contacting the Iranian Consulate but they denied the Petitioner's Iranian citizenship via letter. The Consulate has no record of who the Petitioner is or any documentation of him ever being a citizen of Iran.

After being released Petitioner became a productive member of society. Working steady jobs and even buying a home in California. Petitioner took care of his elderly mother (a U.S. citizen) who in 2023 had a paralyzing stroke and depends on him for everything.

On June 25th 2025 approximately at 9:30am Petitioner was heading to his work that he held for 5 years leaving a home he owns with his 80 year old mother (a U.S. Citizen) and as her sole care taker and provider.

At this moment a black Dodge Durango with lights and sirens came up behind him. The Petitioner pulled over and the ICE agents physically pulled him out of the car and handcuffed him. As they placed him behind the SUV Petitioner asked to see the warrant. No warrant was shown during that time nor after the processing of the Petitioner.

They read Petitioner's name and his mothers name for identity verification but never allowed him to see the warrant. They took his wallet and license and left his car on the street.

We proceeded to drive to the San Bernardino ICE field office where Petitioner was processed.

Afterwards Petitioner was transferred to the downtown Los Angeles ICE main office.

They fed us burritos and juice and never supplied us with blankets or cots even though it was freezing cold. We had to cram and sleep on the floor until the next day.

A lot of the people were there for days and weeks. Petitioner was fortunate as they pulled him out the next day and transferred him to Adelanto ICE Processing Center in Adelanto CA. In which he was housed for a month.

This is the Petitioner's second time in ICE custody in which he was released six years prior on OSUP.

After a month in Adelanto Petitioner was abruptly sent on a flight to San Antonio Texas and transferred to STIPC without prior notice or warning.

Two weeks after being housed in STIPC ICE agents called the Petitioner and was told to sign some documents. Petitioner thought he could get answers to his situation. But his questions were never answered.

Without any documentation or notice to the Petitioner or the government of Rwanda, petitioner finds out that ICE was trying to send him to Rwanda an African country which he has no ties with.

As an Iranian this would put his life in peril. [**Rokhfirooz v. Larose** *U.S. Dist. Court for the Southern Dist. Of California, September 15, 2025*]

Petitioner refuses to sign any documents and the ICE agents told him "its OK that you don't sign we don't need your signature to deport you."

Two days later they attempted to deport the Petitioner along with seven others. they were told to pack up and that they were getting deported. Again they tried to have them sign deportation documents to an African nation which Petitioner does not belong to or have any connection with.

They were driven to a private airport which they had a private jet waiting for them.

As they got out of the van one of the ICE agents asked "which one of you are from Iran?" Petitioner answered "me" then they told him to get back in the van as they took the rest onto the plane.

The Petitioner's family would have never seen him again. Petitioner really felt if he had went to Africa he would have not survived.

Petitioner was transferred back to STIPC and has been here since.

III. PRAYER FOR RELIEF

WHEREFORE, Petitioner prays that this Court grants the following relief:

- 1) Assume jurisdiction over this matter, this court has subject-matter jurisdiction as the Petitioner is a resident of California;
- 2) Grant Petitioner a **Writ of Habeas Corpus** directing the Respondents to immediately release Petitioner from custody;
- 3) Enter a preliminary and permanent injunctive relief enjoining Respondents from further unlawful detention of Petitioner;
- 4) Grant any other and further relief that this Court deems just and proper.

I affirm to the best of my knowledge and belief that the foregoing is true and correct.

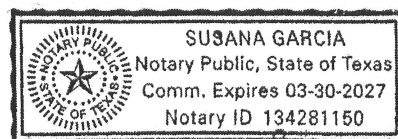


