18 **RESPONDENTS' SUPPLEMENTAL RESPONSE TO PETITION FOR WRIT OF HABEAS**  
19 **CORPUS AND OPPOSITION TO MOTION FOR TEMPORARY RESTRAINING ORDER**

20 On December 29, 2025, counsel for Respondents received this Court's order for all portions of

6 13, and; the first page of the Arrival/Departure Form I-94 ("I-94"), dated October 3, 2022, which was  
7 previously attached to Respondents' Response, ECF 12, as Exhibit 2 and is attached hereto for the
