16 Federal Respondents hereby file their Response to Petitioner Reza Tehrani's  
 17 Petition for a Writ of Habeas Corpus Under 28 U.S.C. § 2241 (ECF No. 4). On January 5,  
 18 2026, Petitioner Reza Tehrani ("Petitioner") filed his Petition for a Writ of Habeas Corpus  
 19 ("Petition"). In his Petition, Petitioner requested to be released from detention and granted  
 20 a bond hearing. (ECF No. 4, Page 8).

21 On January 26, 2026, Petitioner had a bond hearing where the Immigration Judge  
 22 ("IJ") Ordered Petitioner be released from custody under bond of \$3,500.00. See Order of  
 23 the Immigration Judge January 26, 2026, attached hereto as Exhibit A. Since Petitioner has  
 24 been granted the relief he requested in his Petition by the IJ ruling that he be released from  
 25 custody under bond in the amount of \$3,500.00, Federal Respondents' position is that this  
 26 matter is now moot requiring dismissal and no further briefing.
