PETITION FOR WRIT OF HABEAS CORPUS UNDER 28 U.S.C. § 2241

TO THE HONORABLE JUDGE OF THE UNITED STATES DISTRICT COURT:

Petitioner, Giosbani Delgado Rodriguez, A# [REDACTED] and through his next friend and U.S. citizen partner, Sirley Jhoanna Tejeda, respectfully petitions this Honorable Court for a writ of habeas corpus under 28 U.S.C. § 2241 and states the following:

I. INTRODUCTION

1. Petitioner is a Cuban national who entered the United States on April 22, 2022.
2. Petitioner was detained on June 23, 2025, and is currently held at Eden Detention Center in Texas.
3. Petitioner is the primary emotional and financial provider for his partner and their family.
4. Petitioner and Ms. Tejeda share a U.S.-born infant of only 9 months, who was just 3 months old at the time of detention.
5. Petitioner also fulfills the full role of father to Ms. Tejeda's other minor children.
6. Petitioner has no criminal record, no history of violence, and has always lived as an exemplary member of the community.
7. Petitioner's detention has caused severe family separation, emotional trauma, and financial hardship.
8. Due to the extreme stress of detention, Petitioner is experiencing memory loss, disorientation, and confusion.

II. JURISDICTION AND VENUE

9. This Court has jurisdiction under 28 U.S.C. § 2241.

10. Venue is proper in the Northern District of Texas.

III. FACTUAL BACKGROUND

11. Petitioner entered the United States lawfully on April 22, 2022.

12. He was detained on June 23, 2025, despite compliance with immigration requirements and no criminal history.

13. He is the father of a U.S.-citizen infant fully dependent on him.

14. The infant was only three months old when Petitioner was detained.

15. Petitioner also serves as a father figure to Ms. Tejeda's other minor children.

16. His detention has left the family without economic or emotional support.

17. Petitioner suffers severe psychological deterioration due to detention.

18. ICE has less restrictive alternatives, including supervised release or parole.

IV. LEGAL BASIS FOR RELIEF

19. Under *Zadvydas v. Davis*, prolonged detention without justification violates constitutional protections.

20. Under *Demore v. Kim*, detention must be reasonable in duration and purpose.

21. Petitioner's detention violates due process under the Fifth Amendment.

22. Petitioner poses no danger or flight risk and maintains strong family ties.

23. The government has less restrictive alternatives available.

24. Family separation involving a U.S.-citizen infant constitutes extraordinary harm.

V. REQUEST FOR RELIEF

Petitioner respectfully requests that the Court:

1. Order his immediate release from ICE custody under appropriate supervision;
2. Grant a Writ of Habeas Corpus;
3. Order ICE to consider parole or alternatives to detention;
4. Grant any other relief deemed just and proper.

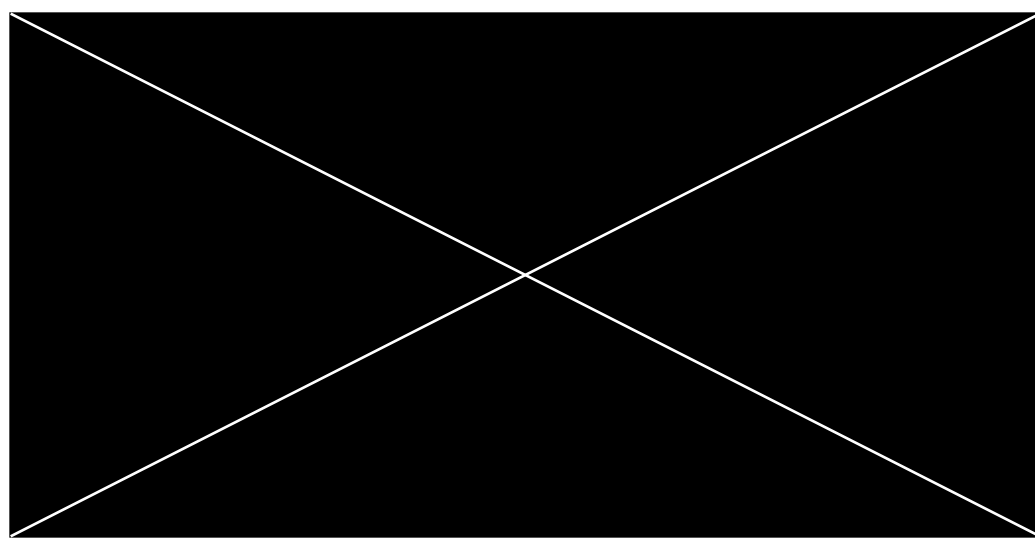

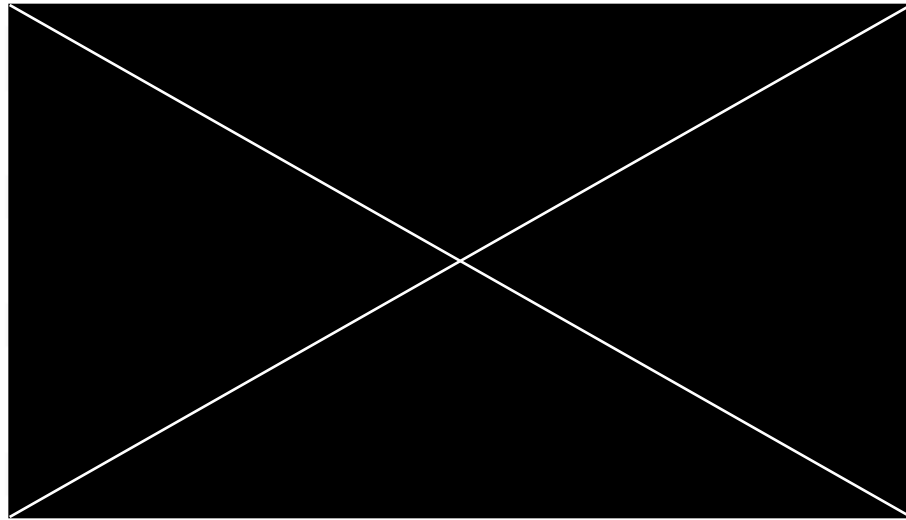

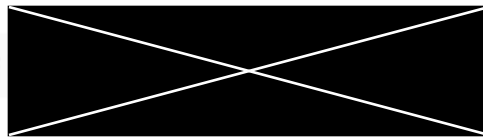

To the Honorable Judge of the United States District Court:

My name is Sirley Jhoanna Tejeda, and I respectfully submit this explanatory letter in support of the Petition for Writ of Habeas Corpus filed on behalf of my partner, Giosbani Delgado Rodriguez, A#  who is currently detained at Eden Detention Center in Texas.

Giosbani entered the United States on April 22, 2022, and since then has been a responsible, hardworking, and family-oriented individual. He has no criminal history, no record of violence, and has always demonstrated exemplary behavior and moral character.

We share a U.S. citizen infant, who is now 9 months old but was only 3 months old when Giosbani was detained on June 23, 2025. The sudden separation has caused severe emotional harm to our baby, who needs his father for bonding, stability, and healthy development. The separation has deeply affected our entire family.

Giosbani is not only the biological father of our infant; he also fulfills the full role of father to my other children. He has been present in every aspect of their lives—emotionally, financially, and as a positive guiding figure. His absence has left the children distressed and missing his support and love.

Giosbani has always been the primary financial provider in our home. Since his detention, our family has suffered extreme financial hardship. I have been left to care for our children alone, while struggling to cover housing costs, food, childcare, and other essential expenses. This situation has placed us under tremendous stress and instability.

Additionally, due to the emotional trauma and stress of detention, Giosbani has started to experience memory loss, disorientation, and confusion. During our phone calls, he forgets what he is talking about, becomes mentally overwhelmed, and struggles to communicate. This decline is alarming and clearly shows the psychological harm caused by continued detention.

Giosbani is not a danger to the community, not a flight risk, and has strong and permanent ties to the United States. His continued detention is unnecessary, harmful, and disproportionately affecting our infant and family.

For these reasons, I respectfully ask this Court to grant his release while his immigration case proceeds. Our baby desperately needs his father, and our family cannot continue to endure this emotional and financial suffering.

Thank you for your time, understanding, and consideration.

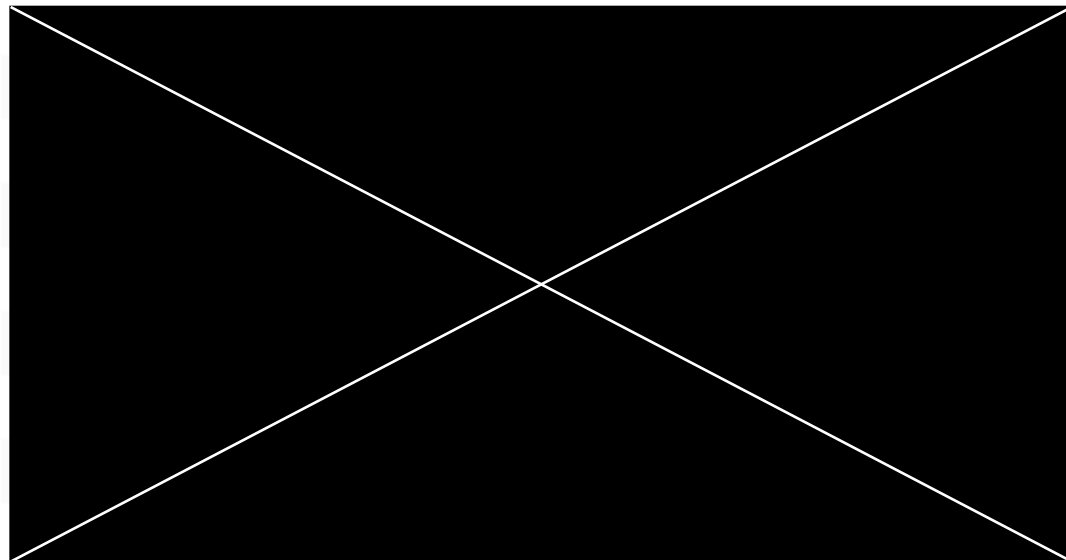

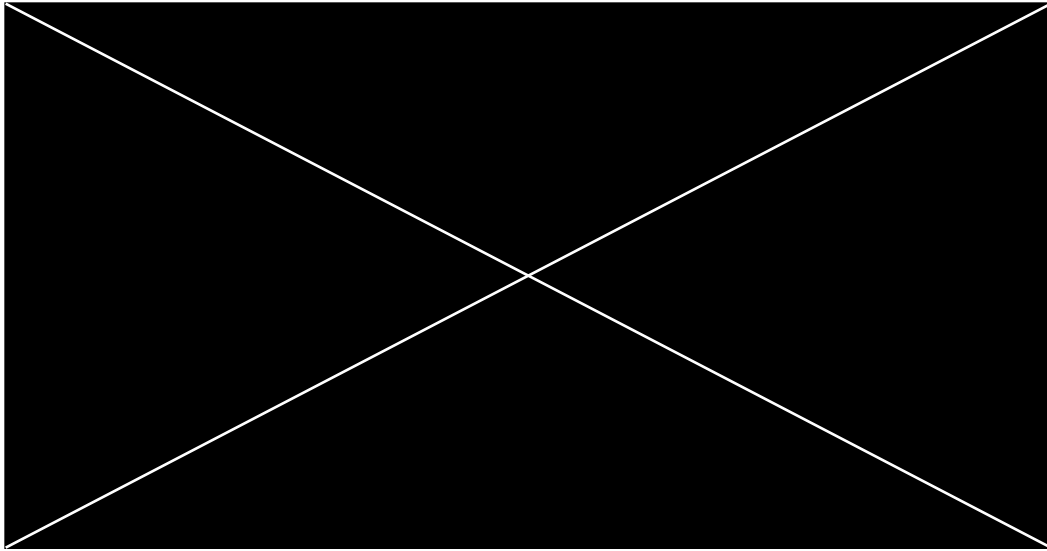

INTERIM NOTICE AUTHORIZING PAROLE

This letter is to inform you that U.S. Immigration and Customs Enforcement (ICE) has decided to parole you from its custody pursuant to its authority under section 212(d)(5)(A) of the Immigration and Nationality Act. This notice is being issued to you in lieu of Form I-94, *Arrival-Departure Record*, see 8 C.F.R. § 235.3(h)(2), and you should maintain a copy of this letter in your possession at all times.

Your parole authorization is valid for one year beginning from the date on this notice and will automatically terminate upon your departure or removal from the United States or at the end of the one-year period unless ICE provides you with an extension at its discretion. ICE may also terminate parole on notice prior to the automatic termination date. Parole is entirely within the discretion of ICE and can be terminated at any time and for any reason. Your parole is not valid for work authorization and is not an admission in lawful status.

Parole is conditioned on you complying with the terms and conditions of your release. You must notify ICE and the immigration judge of any address correction or address change. You must report for every scheduled hearing before the immigration court and every appointment as directed by ICE (including for removal from the United States should you become subject to a final removal order). You must not violate any local, State or Federal laws or ordinances. You must comply with any other specified conditions if identified separately.
