Petitioner, Tra Bi Jean, hereby stipulates that this action be dismissed without prejudice as to all claims, causes of action, and parties, with each party bearing their own attorney's fees and costs, pursuant to Federal Rule of Civil Procedure 41(a)(1)(A)(ii). Petitioner filed the instant habeas petition on December 5, 2025, indicating that he had a bond hearing scheduled for December 10, 2025. Dkt. 1. Petitioner believed that he would be subject to mandatory detention under 8 U.S.C. § 1225(b)(2) because the Department of Homeland Security charged him as

1 removable under 8 U.S.C. § 1182(a)(7)(A)(i)(I) in his Notice to Appear (NTA). This Court issued
2 an Order to Show Cause, directing Federal Respondents to file a return no later than December
3 12, 2025, with any traverse by Petitioner to be filed by December 15, 2025. Dkt 5.

4 At the bond hearing on December 10, 2025, the Immigration Judge found that Petitioner
5 was improperly charged in his NTA and that he did have an admission to the United States and
6 therefore, should be charged under 8 U.S.C. § 1227. Because of this, the Immigration Judge found
7 he had jurisdiction, did not find Petitioner to be either a danger or a flight risk, and ordered
8 Petitioner's release upon payment of bond in the amount of \$5,000. Petitioner has now been
9 released from custody.

10 Accordingly, Petitioner has now agreed to dismiss the instant habeas petition.
