**DECLARATION OF
LA'SHANIECE WILSON**

I, La'Shaniece Wilson, pursuant to 28 U.S.C. § 1746, hereby declare under penalty of perjury that the following statements are true and correct, to the best of my knowledge, information, and belief:

1. I am employed by the U.S. Department of Homeland Security (DHS), Immigration and Customs Enforcement (ICE), Enforcement and Removal Operations (ERO), in the San Diego Field Office, as a Deportation Officer (DO). I have held this position since December 29, 2024.

2. I am currently assigned to the Otay Mesa suboffice and my responsibilities include enforcing final orders of deportation and removal from the United States for aliens and requesting travel documents from foreign consulates as part of the removal process.

1 3. I am currently responsible for monitoring this case. I make this declaration
2 based upon my own personal knowledge and experience as a law enforcement officer and
3 information provided to me in my official capacity as a DO in the ICE ERO San Diego Field
4 Office. I make this declaration based on review of Petitioner Hoang Kiet Lam’s alien file,
5 consultation with other ICE officers, and review of official documents and records
6 maintained by ICE.

7 4. On December 16, 2025, Petitioner was released from ICE custody pursuant to
8 the Court’s order in *Lam v. Noem et al.*, Case No. 25-cv-3470-JO-VET, ECF No. 9 (S.D.
9 Cal. Dec. 16, 2025).

10 5. I declare under penalty of perjury of the laws of the United States of America
11 that the foregoing is true and correct.
