

Mr. Garcia Hernandez is currently detained by U.S. Immigration and Customs Enforcement (ICE) at the Otay Mesa Detention Center, San Diego, California. He was detained on October 27, 2025 at the entrance of a military base where he was employed.

Mr. Garcia Hernandez is a current DACA recipient and has a pending DACA renewal and Employment Authorization renewal filed on November 21, 2025.

Mr. Garcia Hernandez does not pose a danger to the community nor a flight risk. His continued detention is unnecessary and unjustified.

WHEREFORE, Petitioner respectfully requests that this Honorable Court grant this Petition and order his immediate release from ICE custody while his immigration matters are adjudicated.
