Mr. Garcia Perez is currently detained by U.S. Immigration and Customs Enforcement (ICE) at the Otay Mesa Detention Center, San Diego, California.

He was detained on October 27, 2025 while working at a military base.

Mr. Garcia Perez remains in custody despite having active immigration relief pending, including:

- A pending U Visa application.
- A family-based petition filed by his son, who actively serves in the United States Army.
- A family-based petition filed by his sister.

Mr. Garcia Perez does not pose a danger to the community nor a flight risk. His continued detention is unnecessary and causes irreparable harm to his family.

WHEREFORE, Petitioner respectfully requests that this Honorable Court grant this Petition and order his immediate release from ICE custody while his immigration proceedings continue.
