**DECLARATION OF
DEPORTATION OFFICER
MAYRA GALLENKAMP**

I, Mayra GallenKamp, make the following statements under oath and subject to the penalty of perjury:

1. I am a Deportation Officer (DO) with the U.S. Department of Homeland Security (DHS), U.S. Immigration and Customs Enforcement (ICE), Enforcement and Removal Operations (ERO), in the Fresno, California, Sub-Office of the San Francisco Field Office. I have been employed with DHS since March 3, 2019. I currently serve as a DO and am assigned to the ERO Fresno Sub-Office's Detained Unit, which oversees the aliens detained at the Golden State Annex (GSA), which is a contract detention facility in McFarland, California managed by the GEO Group Inc. (GEO).

2. My responsibilities include, but are not limited to, tracking the progression of detained cases through removal proceedings, tracking detained cases with final removal orders, obtaining travel documents for aliens ordered removed, and effectuating the removal of aliens to other countries.

1 3. I am the assigned Deportation Officer in the case of Deepak Sharma (Petitioner). The
2 facts in this declaration are based on my personal and professional knowledge, consultation with other
3 DHS and ICE personnel, and reasonable review of official documents, systems, and records maintained
4 by the agency and DHS, and other relevant sources during the regular course of my duties.

5 4. I am familiar with ICE policies and procedures governing the detention and removal of
6 aliens who come into ICE's custody. ICE is charged with removing aliens who lack lawful immigration
7 status in the United States. I have obtained and attached to my declaration true and correct copies of the
8 following documents from the above-named Petitioner's case file and records maintained by DHS,
9 which will be referenced as Exhibits (Ex.) as follows:

23 5. Petitioner is a native and citizen of India who entered the United States, on or about July
24 16, 2019, approximately six miles northwest of the San Luis, Arizona, and was detained by U.S. Border
25 Patrol. Ex. 1.

26 6. Petitioner did not possess any immigration documents that would allow him to enter or
27 remain in the United States. *Id.*

1 7. On or about July 16, 2019, Petitioner was issued a Form I-862 Notice to Appear. *See* Ex.
2 2.

3 8. On or about September 6, 2019, Petitioner was released on parole from the Office of
4 Refugee Resettlement and issued a Form I-830E Notice to EOIR Alien Address and Form I-831 New
5 Court Location. *See* Ex. 3.

6 9. On or about June 5, 2024, Petitioner was arrested for Assault with Deadly Weapon Not a
7 Firearm, in violation of California Penal Code (CPC) section 241(a)(1) and Exhibit Deadly Weapon Not
8 a Firearm, in violation of California Penal Code (CPC) section 417(a)(1). *See* Ex. 4.

9 10. On or about January 2, 2025, Petitioner was arrested for Domestic Battery, in violation of
10 CPC section 243(e)(1). *See* Exs. 4 and 5.

11 11. On or about January 7, 2025, the Superior Court of California, County of San Joaquin,
12 convicted Petitioner of Assault by means likely to produce Great Bodily Injury, in violation of CPC
13 section 245(a)(4), and sentenced him to 45 days in jail and 1 year probation. *See* Exs. 4 - 6.

14 12. On or about June 26, 2025, Petitioner was ordered removed to India by an Immigration
15 Judge in Concord, CA. Ex. 7.

16 13. On or about June 26, 2025, ERO took Petitioner back into DHS custody and served him
17 with a Warrant of Removal Form I-205 and Form I-294 Warning to Alien Ordered Removed. Ex. 8.

18 14. Petitioner is currently detained at Golden State Annex (GSA) under section 235(b)(2) of
19 the INA. Ex. 5.

20 15. On or about July 15, 2025, Petitioner filed an appeal with the Board of Immigration
21 Appeals (BIA). Ex. 9. The appeal is currently pending, which automatically stays removal pending
22 further order of the BIA.

23 I declare, under penalty of perjury, under 28 U.S.C. § 1746, that the foregoing is true and correct
24 to best of my knowledge, information, belief, and reasonable inquiry.

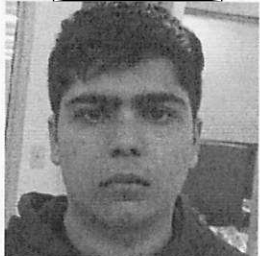

On 06/25/2025, the above targets were positively identified by ICE ERO as potential immigration violators. On 06/25/2025, Field Operation Worksheets (FOWs) were created to target all the above subjects.

U.S. Immigration and Customs Enforcement (ICE) Enforcement and Removal Operations (ERO) has determined this case is a priority.			
DEEPAK, Sharma (DOB:  , ) came to the attention of ICE ERO. On 06/26/2025, DEEPAK has been ordered removed to India by an Immigration Judge in Concord, CA. DEEPAK will be processed as a Final Order, Bag & Baggage. DEEPAK is a citizen and native of India. An immigration investigation was conducted by reviewing the subject's records checks in ICE ERO databases (CIS, CLAIMS, PCQS, and EARM). It was determined that DEEPAK is amenable to enforcement due to possessing a final order of removal from an immigration judge. Due to the above-mentioned factors a Field Operations Worksheet (FOW) was generated and approved for enforcement. The photo and description of DEEPAK was gathered through Field Operations Intelligence.			
ARREST & ENCOUNTER:			
At approximately 1055 hours, DO Ho, and DO Hubbard observed an adult male matching the description of DEEPAK walking towards the lobby elevators located at the tenth floor of Concord EOIR. DO Ho and DO Hubbard approached the subject and identified themselves as "Police" and immigration officers. DO Ho positively identified the subject as DEEPAK. DO Ho told the subject that he was under arrest and instructed him to put his hands behind his

back. DO Ho maintained control of DEEPAK's hands as she placed DEEPAK under handcuffs, which were checked for tightness and double locked, per ICE policy. DO Hubbard patted down (searched) DEEPAK. DEEPAK was transported by G4S detention officers to a safer location a few minutes away where he was fully searched and placed in full restraints per ICE policy. DEEPAK and his personal property were transported by G4S detention officers to the Stockton ICE ERO field office located at 603 San Juan Ave, Stockton, CA 95203 for further processing.		
IMMIGRATION HISTORY:		
On 07/15/2019, DEEPAK entered the United States as a juvenile and was released on parole. On 06/26/2025, DEEPAK has been ordered removed to India by an Immigration Judge in Concord, CA.

HEALTH AND HUMANITARIAN ADDENDUM:		
DEEPAK claims no medical issues. Subject stated he has no dependents. Subject stated that he is not a member or associate of any gangs.		
DISPOSITION:		
The subject is being processed as a Final Order, Bag & Baggage. Subject was served I-205 Warrant of Removal, and I-294 Warning to Alien Ordered Removed. The subject will remain in ICE custody.
