My name is Anjal Gautam I'm from Nepal, I left my house at the age of 18 Because of the fear of staying in my country and I had cross the boarder illegally just to save my life and i agree and I am been caught by the boarder petrol and was detained since 01/05/2025 I receive an interview after one and 2 weeks by an asylum officer and my interview was a positive then i was giving a court date within 15days and the judge told me I have to fight my case from inside the detantion which is very diffucult for me because I don't have a father they people who are after my life killed my father . I don't have anybody in my family who is supporting me financialy like to pay for my phone calls, my commisary and because of these i can't even call my family. The food which they give us is very bad which I never ate in my house every monrning they wake us up at 5 for breakfast , I can't even sleep at night because of the thoughts coming in my mind of my family and myself, the life which I am suffring wihout any crime. And I fell like I'm been controled mentally and physically by the officers and I'm frustrated overhere and because I had nobody for me to arrange my evidences it take a long time for me to submite my evidences and after the judge give me an individual hearing after 4 months and my individual is on the 03/03/2026 and I can't stay no longer in the detention beacause I'm not a criminal I cross the boarder illigally just to safe my life. And I appologize and I am sorry for that please let me go oustside and fight my case with peace of mind and good health and good food and also talk to my family with no stress and a sleep too. I will stay with my sponsor I'm not running anywhere for the immigration I want to face my individual from outside. This is a humble request from a 19 years old boy who is asking this honorable judge for me to realese from coustdy.I can't stay here no longer I'm going crazy overhere

PETITION FOR A WRIT OF HABEAS CORPUS UNDER 28 U.S.C. § 2241

Instructions

1. **Who Should Use This Form.** You should use this form if
 - you are a federal prisoner and you wish to challenge the way your sentence is being carried out (*for example, you claim that the Bureau of Prisons miscalculated your sentence or failed to properly award good time credits*);
 - you are in federal or state custody because of something other than a judgment of conviction (*for example, you are in pretrial detention or are awaiting extradition*); or
 - you are alleging that you are illegally detained in immigration custody.
2. **Who Should Not Use This Form.** You should not use this form if
 - you are challenging the validity of a federal judgment of conviction and sentence (*these challenges are generally raised in a motion under 28 U.S.C. § 2255*);
 - you are challenging the validity of a state judgment of conviction and sentence (*these challenges are generally raised in a petition under 28 U.S.C. § 2254*); or
 - you are challenging a final order of removal in an immigration case (*these challenges are generally raised in a petition for review directly with a United States Court of Appeals*).
3. **Preparing the Petition.** The petition must be typed or neatly written, and you must sign and date it under penalty of perjury. **A false statement may lead to prosecution.**
4. **Answer all the questions.** You do not need to cite law. You may submit additional pages if necessary. If you do not fill out the form properly, you will be asked to submit additional or correct information. If you want to submit any legal arguments, you must submit them in a separate memorandum. Be aware that any such memorandum may be subject to page limits set forth in the local rules of the court where you file this petition. If you attach additional pages, number the pages and identify which section of the petition is being continued. All filings must be submitted on paper sized 8½ by 11 inches. **Do not use the back of any page.**
5. **Supporting Documents.** In addition to your petition, you must send to the court a copy of the decisions you are challenging and a copy of any briefs or administrative remedy forms filed in your case.
6. **Required Filing Fee.** You must include the \$5 filing fee required by 28 U.S.C. § 1914(a). If you are unable to pay the filing fee, you must ask the court for permission to proceed in forma pauperis – that is, as a person who cannot pay the filing fee – by submitting the documents that the court requires.
7. **Submitting Documents to the Court.** Mail your petition and copies to the clerk of the United States District Court for the district and division in which you are confined. For a list of districts and divisions, see 28 U.S.C. §§ 81-131. All copies must be identical to the original. Copies may be legibly handwritten.

If you want a file-stamped copy of the petition, you must enclose an additional copy of the petition and ask the court to file-stamp it and return it to you.
8. **Change of Address.** You must immediately notify the court in writing of any change of address. If you do not, the court may dismiss your case.
