PETITIONER-PLAINTIFF'S NOTICE OF SUPPLEMENTAL AUTHORITY

Petitioner-Plaintiff advises the Court of relevant supplemental authority. Two separate courts recently rendered judgments and issued orders since Petitioner-Plaintiff initiated this action. Below is a summary of both.

The District of Massachusetts granted partial summary judgment to a regional class of detained noncitizens in *Guerrero Orellano v. Moniz* on December 19, 2025. Ex. 1, Memorandum and Order, No. 1:25-cv-12664 (D. Mass. Dec. 19, 2025) & Ex. 2, Partial Final Judgment. The District of Massachusetts granted a declaratory judgment to the class, ordered notice to the class, and entered partial final judgment pursuant to Federal Rule of Civil Procedure 54(b). *See id.*

The day prior, the Central District of California issued two orders and a final judgment in *Maldonado Bautista v. Santacruz*, No 5:25-cv-1873 (C.D. Cal. Dec. 18, 2025). The court's final judgement pursuant to Federal Rule of Civil Procedure 54(b) is attached as Exhibit 3, while the court's orders are attached as Exhibit 4.
