II. JURISDICTION AND VENUE

Jurisdiction is proper under 28 U.S.C. §2241, as Petitioner challenges the legality of his detention. Venue is proper in the Western District of Texas because Petitioner is detained within this District.

III. STATEMENT OF FACTS

1. Petitioner entered the United States on August 29, 2022, and was detained for approximately three months until his release on November 15, 2022. He complied fully with all ICE requirements following his release.

2. Petitioner fled Venezuela because his life was in imminent danger due to threats from criminal groups.


3. Petitioner applied for asylum. Although the Immigration Judge found his testimony and claims credible, the claim was denied based on a misunderstanding regarding why his wife had not left Venezuela at the same time. Petitioner explained he only had enough money to leave first, while his wife hid in her mother's home in another city until he could gather the funds to help her escape.

4. Petitioner and his wife share a minor daughter, who has suffered severe emotional and academic deterioration due to her father's detention. She has stopped eating normally, her grades have declined, and she is under emotional distress.

5. Petitioner was the emotional and financial provider of his household. He maintained stable employment and attended every single ICE check-in without fail.

6. Petitioner was again detained by ICE on November 4, 2025, despite having no criminal history in the United States or Venezuela. He is a model husband, father, and community member.

7. After Petitioner's detention, the criminal group in Venezuela discovered his situation and



8. Petitioner has suffered physical and emotional deterioration during detention, including weight loss, poor nutrition, and high levels of anxiety due to family separation and detention conditions.

9. During video calls, Petitioner appears afraid to speak openly. He tells his wife that "everything is recorded," suggesting possible psychological intimidation inside the facility.

10. Petitioner has an approved credible fear interview, confirming that he faces a high risk of persecution, torture, or death if returned to Venezuela.

IV. LEGAL BASIS FOR RELIEF

1. The Fifth Amendment prohibits prolonged, punitive, or unnecessary detention, especially when the individual poses no danger or flight risk.

2. Petitioner has no criminal history, has demonstrated compliance with ICE, and has substantial family ties in the United States.

3. Under *Zadvydas v. Davis*, detention cannot be indefinite or punitive where removal is not reasonably foreseeable, particularly when the individual has credible fear established.

4. Petitioner faces imminent danger if deported. His credible fear approval, combined with recent violent attacks on his family, establishes extreme risk.

5. ICE has alternatives to detention, including supervised release, ankle monitoring, or periodic check-ins—methods Petitioner has already demonstrated he can comply with.

V. REQUEST FOR RELIEF

Petitioner respectfully requests that this Court:

1. Order his immediate release from ICE custody;
2. Permit supervised release or alternative conditions of supervision;
3. Grant any further relief that the Court deems appropriate.


My name is Emili Sttephany Rodríguez de Romero, A#  and I respectfully submit this letter in support of my husband, Rafael José Romero López, who is currently detained at the Bluebonnet Detention Center. I write this letter as his wife, his next friend, and the person who knows most deeply the suffering, danger, and emotional harm that his continued detention has caused to our family.

My husband entered the United States on August 29, 2022, after fleeing Venezuela because his life was in imminent danger. We only had enough money for one person to leave the country at that time. I was forced to hide in another city with my mother until he could gather the funds to help me escape as well. The threats against him and our family were very real and very serious.

After being detained for three months upon his entry, Rafael was released on November 15, 2022, and since then he complied with every single ICE check-in, never missing any appointment. He worked hard to support us and was the emotional and economic foundation of our home. Rafael is a good man, a responsible father, and a loving husband. He has no criminal record, neither in the United States nor in Venezuela.

We have a minor daughter, and she has suffered tremendously since her father was detained again on November 4, 2025. She has become emotionally unstable, has stopped eating normally, cries for her father every day, and her academic performance has significantly declined. As her mother, I am extremely worried about the long-lasting emotional harm this separation is causing her.

After Rafael's detention, the same criminal group 


member. These threats have placed our entire family in extreme fear. Returning my husband to Venezuela would put him—and us—in grave danger.

During our video calls, my husband is afraid to speak freely. He looks nervous and tells me that "everything is recorded," which makes me believe he may be experiencing psychological pressure or intimidation inside the detention center. He also looks weak, sad, and physically deteriorated due to poor nutrition and the emotional stress of being separated from us.

Rafael has an approved credible fear interview, confirming the danger he faces if removed from the United States. Keeping him detained serves no purpose and only worsens the harm already done to him and to our family. ICE has alternatives to detention, and Rafael has shown he can comply with all requirements responsibly.


