

I. PARTIES & CUSTODY

1. Petitioner Dayneris Perez-Blanco is currently detained at the Immigration and Customs Enforcement (“ICE”) Montgomery Processing Center, located at 806 Hilbig Road, Conroe, TX 77301. She has been in ICE custody since December 3, 2025.
2. Respondent Randy Tate, in his official capacity as Warden of the Montgomery Processing Center, has refused to effect Petitioner’s release from unlawful custody at that facility.
3. Respondent Bret Bradford, in his official capacity as Director of the Houston Field Office of ICE Enforcement and Removal Operations, has refused to effect Petitioner’s release from unlawful custody at the Montgomery Processing Center.
4. Respondent Kristi Noem, in her official capacity as Secretary of the United States Department of Homeland Security, has refused to exercise her authority to oversee her department’s ICE Enforcement and Removal Operations and thereby effect Petitioner’s release from unlawful custody at the Montgomery Processing Center.
5. Respondent Pam Bondi, in her official capacity as Attorney General of the United States, has refused to exercise her authority to oversee her department’s ICE Enforcement and Removal Operations and thereby effect Petitioner’s release from unlawful custody at the Montgomery Processing Center.

II. JURISDICTION & VENUE

6. This Court has jurisdiction pursuant to 28 U.S.C. § 2241 to issue writs of habeas corpus when the petitioner is in custody in violation of the Constitution or laws of the United States.
7. Venue is proper in this district because Petitioner is detained within this district.

III. EXHAUSTION OF ADMINISTRATIVE REMEDIES

8. Petitioner has exhausted her administrative remedies to the extent required by law.
9. Petitioner has fully cooperated with Respondents and has not delayed or obstructed her detention.
10. Petitioner's only remedy is by way of this judicial action.

IV. FACTUAL AND PROCEDURAL BACKGROUND

11. Petitioner Dayneris Perez Blanco is a 35-year-old female native and citizen of Cuba. *See attached*, Exhibit A, ID. Petitioner last entered the United States without inspection on or about February 14, 2022, at or near Del Rio, Texas. *See attached*, Exhibit B, Notice to Appear; Exhibit C, Form I-589.
12. On or about February 17, 2022, the Department of Homeland Security ("DHS") served Petitioner with a Notice to Appear, charging her as removable as an alien present in the United States without being admitted or paroled. Removal proceedings were initiated before the Immigration Court, now venued in Conroe, Texas. *See attached*, Exhibit B, Notice to Appear; Exhibit D, EOIR Automated Case Information.

13. Petitioner fears that, if returned to Cuba, she would face serious harm, persecution, and torture on account of her political opinions and opposition to the Cuban government, and she has expressed her intent to seek protection in the United States. *See attached*, Exhibit C, Form I-589.
14. On or about December 3, 2025, Petitioner was taken into custody by U.S. Immigration and Customs Enforcement (“ICE”) following an ICE check-in. She is currently detained at the Montgomery Processing Center in Conroe, Texas. *See attached*, Exhibit E, ICE Detainee Locator.
15. Petitioner sought release from detention by filing a Motion for Bond Redetermination Hearing pursuant to 8 U.S.C. § 1226(a). On December 12, 2025, the Immigration Judge denied bond, concluding that the court lacked jurisdiction to grant her release. *See attached*, Exhibit F, Bond Motion and Order.
16. Petitioner’s removal proceedings are ongoing and not final. Her case remains pending before the Conroe Immigration Court, with a Master Calendar Hearing scheduled for January 21, 2026, at 9:00 a.m. No final order of removal has been entered in her case. *See attached*, Exhibit D, EOIR Automated Case Information.
17. As a result of the bond denial, Petitioner remains detained without any individualized determination that her continued detention is necessary to prevent flight or danger to the community. Petitioner has no criminal history, has a fixed address and sponsor in the community, and has been pursuing relief from removal in good faith. *See attached*, Exhibit G, Bond Request and Supporting Documents.

18. Petitioner's continued detention is prolonged and indefinite in nature, as her removal proceedings remain pending and are not scheduled for completion in the near future. ICE has not identified a foreseeable end date to Petitioner's detention. *See attached*, Exhibit D, EOIR Automated Case Information.
19. The government has not been able to articulate any meaningful reason why Petitioner should continue to remain in detention pending the outcome of her removal proceedings.
20. Petitioner, through Counsel, now submits the present Petition for Writ of Habeas Corpus to this Honorable Court, and respectfully requests the Court to order Respondents to effect her immediate release.

V. LEGAL FRAMEWORK FOR RELIEF SOUGHT

21. Under U.S. Code 28 § 2241, writs of habeas corpus may be granted by the district courts on behalf of a prisoner in several instances, including when they are (1) "in custody under or by the authority of the United States or is committed for trial before some court thereof," (3) "in custody in violation of the Constitution or laws and treaties of the United States," and (4) when they, "being a citizen of a foreign state and domiciled therein [are] in custody for an act done or omitted under any alleged right, title, authority, privilege, protection, or exemption claimed under the commission, order or sanction of any foreign state, or under color thereof, the validity and effect of which depend upon the law of nations[.]"
22. Courts have consistently recognized "habeas corpus as an appropriate vehicle through which noncitizens may challenge the fact of their civil immigration detention." *Vazquez Barrera v. Wolf*, 455 F. Supp. 3d 330, 336 (S.D. Tex. 2020) (citing *Zadvydas v. Davis* ,

533 U.S. at 688 (ruling on merits of habeas petition challenging validity of indefinite mandatory detention)).

VI. CLAIMS FOR RELIEF

COUNT ONE:

**RESPONDENTS HAVE UNLAWFULLY DETAINED PETITIONER
IN VIOLATION OF THE IMMIGRATION AND NATURALIZATION ACT.**

23. Petitioner alleges and incorporates by reference paragraphs 1 through 22 above.
24. Petitioner's removal proceedings are ongoing and not final. No final order of removal has been entered, and Petitioner remains in active proceedings before the Conroe Immigration Court, with a Master Calendar Hearing scheduled for January 21, 2026.
25. Petitioner poses no risk of danger to the community. In the three years since Petitioner came to the United States, she has never been charged with a crime, nor has she demonstrated any conduct whatsoever indicating that she is a threat to the United States or otherwise eligible for deportation.
26. Therefore, **Petitioner merits immediate release** because there has been no final order of removal issued against her, and the government cannot articulate any meaningful reason why she should continue to remain in detention while her removal proceedings are pending.

COUNT TWO:

**RESPONDENTS HAVE UNLAWFULLY DETAINED PETITIONER
IN VIOLATION OF CONSTITUTIONAL DUE PROCESS**

27. Petitioner alleges and incorporates by reference paragraphs 1 through 26 above.

28. Petitioner's continued detention violates her right to substantive and procedural due process guaranteed by the Fifth Amendment to the U.S. Constitution.

29. Petitioner is unlawfully in custody pursuant to INA § 241(a)(6), 8 U.S.C. § 1231(a)(6) (2018) ("Section 241"). Under *Zadvydas*, that provision prohibits the indefinite detention of noncitizens who (i) cannot be repatriated in the reasonably foreseeable future, and (ii) pose no threat to the community. Any such detention is unconstitutional. *See Zadvydas*, 533 U.S. at 689, emphasis added ("In our view, the statute [Section 241], read in light of the Constitution's demands, limits an alien's post-removal-period detention to a period reasonably necessary to bring about that alien's removal from the United States. It does not permit indefinite detention.").

30. The Fifth Amendment's Due Process Clause prohibits the government from detaining individuals without legal authority.

31. Under 8 U.S.C. § 1231(a)(1), detention during the removal period is only authorized after a removal order becomes "final."

32. As stated above, Petitioner's removal proceedings are ongoing and not final. No final order of removal has been entered, and Petitioner remains in active proceedings before the Conroe Immigration Court, with a Master Calendar Hearing scheduled for January 21, 2026.

33. Habeas corpus remains available to challenge unlawful civil immigration detention where the government exceeds its statutory authority. *See Zadvydas*, 533 U.S. at 688 (“The aliens here, however, do not seek review of the Attorney General's exercise of discretion; rather, they challenge the extent of the Attorney General's authority under the post-removal-period detention statute. And the extent of that authority is not a matter of discretion . . . [therefore we] conclude habeas corpus proceedings remain available. . . .”).
34. Therefore, this petition is not barred, as the Petitioner is not seeking to collaterally attack the final removal order, because a final order does not yet exist while the appeal is pending.
35. Petitioner's continued detention lacks statutory authority and violates her right to substantive due process under the Constitution. Therefore, she should be immediately released from custody.

VII. REQUEST FOR RELIEF

WHEREFORE, Petitioner Dayneris Perez-Blanco respectfully requests that this Honorable Court **IMMEDIATELY** issue a temporary restraining order:

1. **Directing Respondents to immediately release Petitioner from custody;**
2. In the alternative, if immediate release is not ordered, directing Respondents to provide Petitioner with a prompt, individualized bond hearing governed by INA § 236(a), 8 U.S.C. § 1226(a).
3. Restraining and enjoining Respondent, their agents, employees, and successors from removing Petitioner from the United States;
4. Directing Respondent to take all necessary steps to halt any removal preparations;
5. Requiring Respondent to notify all relevant personnel that Petitioner shall not be removed;

6. Set an expedited hearing on Petitioner's motion for preliminary injunction;
7. After hearing, issue a preliminary injunction maintaining the relief requested above during the pendency of this action;
8. Waive or set security in a nominal amount;
9. Award attorney's fees and costs; and
10. Grant such other relief as this Court deems just and proper.
