1 Petitioner respectfully notifies the Court that as of the time of filing of this
2 report, the Petitioner remains in ICE custody. The Petitioner's sponsor began the
3 bond posting process on December 25, 2025, and has posted bond in the amount of
4 \$1,500 via the CE Bonds online portal. As of approximately 1:47 p.m. on December
5 29, 2025, and prior to the 3:00 p.m. bond posting cut-off, the Petitioner's CE Bond
6 status reflected that "the I-352 bond contract was approved and that the release
7 process for the associated alien will proceed." See Exh. 1. The Petitioner was not
8 released yesterday. Petitioner's counsel inquired with ICE and has been informed
9 that the Petitioner should be released this evening. Should any changes or delays
10 occur with the anticipated release schedule, Petitioner's counsel will inform the
11 Court.
