**VOLUNTARY DISMISSAL OF  
PETITION FOR WRIT OF  
HABEAS CORPUS WITHOUT  
PREJUDICE**

1 INTRODUCTION

2 1. Now comes David L. Dawson, Counsel for Petitioner, and hereby states the  
3 following.

4 2. On Friday, January 2, 2026, Counsel for Petitioner learned that Petitioner's family  
5 was able to pay her \$1,500 bond. Upon payment of this bond, Petitioner was released from the  
6 custody of Respondents on January 1, 2026.

7 3. As of today, January 2, 2026, Petitioner's information does not appear on the ICE  
8 detainee locator website (<https://locator.ice.gov/>) when entering her individual case information,  
9 indicating she is not in custody.

10 4. As Petitioner is no longer in the custody of the Respondents, Petitioner moves this  
11 honorable Court to voluntarily dismiss her Petition for Writ of Habeas Corpus filed on December  
12 22, 2025 without prejudice in accordance with Federal Rule of Civil Procedure 41(a).

13 5. Respondents have not yet served a Return, motion for summary judgment, or  
14 response to the Court's December 30, 2025 scheduling order in this action.

15 6. Accordingly Petitioner voluntarily dismisses her Petition for Habeas Corpus  
16 without prejudice.
