**PETITION FOR WRIT

**INTRODUCTION**

The Respondents are unlawfully detaining Petitioner Leticia Lopez Penaloza, at the Eloy Detention Center, due to the Department of Homeland Security (DHS) recently changed its long-standing position with regard to the status of mandatory detention. *See*, ICE Memo: Interim Guidance Regarding Detention Authority for Applications for Admission filed herewith as Exhibit 1. The Bureau of Immigration Appeals (BIA)

1 issued a precedential decision on September 5, 2025, holding that all noncitizens present  
2 in the United States without admission – no matter how long they have resided here –  
3 are still “applicants for admission” under 8 U.S.C. § 1225(a) and not entitled to bond  
4 hearings because they are subject to mandatory detention under § 1225(b)(2)(A). *See*,  
5 *Matter of Yajure Hurtado*, 29 I&N Dec. 216 (B.I.A. 2025) filed herewith as Exhibit 2.  
6

7  
8 But this interpretation of the Immigration and Naturalization Act (INA) violates  
9 both procedural and substantive Fifth Amendment protections, ignores the plain  
10 statutory language of both § 1225 and § 1226, and is contrary to numerous recent Federal  
11 Court decisions in this District that have rejected these exact arguments. *See e.g.*  
12 10/3/2025 Order entered in *Francisco Echevarria v. Pam Bondi, et al.*, CV-25-03252-  
13 PHX-DWL (ESW), (D. Ariz. 10/3/2025), filed herewith as Exhibit 16.  
14

15 Petitioner filed an Application for Cancellation of Removal for Certain  
16 Nonpermanent Residents, which shows that she has been living in the United States for  
17 22 years. *See*, Petitioner’s Application for Cancellation of Removal for Certain  
18 Nonpermanent Residents, filed herewith as Exhibit 6. Petitioner has no criminal history.  
19 *See*, Declaration of Counsel in Support of Petition for Writ of Habeas Corpus, filed  
20 herewith as Exhibit 4. Further, when Respondents issued a Notice to Appear, it  
21 identified Petitioner as an “alien present in the United States” despite “arriving alien”  
22 being an option. *See*, Petitioner’s Notice to Appear, filed herewith as Exhibit 5.  
23  
24  
25

26 In addition to BIA decisions not being binding precedent upon this Court, the  
27 Supreme Court decision last year in *Loper Bright Enterprises v. Raimondo*, 603 U.S.  
28

1 369, 400 (2024), made clear that federal courts must independently interpret statutes and  
2 no longer defer under so-called “Chevron deference.” This Court is therefore in the best  
3 position to determine whether the Respondents are misinterpreting the relevant federal  
4 statutes and improperly denying alien detainees bond hearings on the grounds that they  
5 are all subject to mandatory detention under § 1225(b)(2)(A). The petition for writ of  
6 habeas corpus should be granted.  
7  
8

### 9 JURISDICTION & CUSTODY

10 1. Petitioner Leticia Lopez Penaloza, is in the physical custody of  
11 Respondents and Immigration and Customs Enforcement (ICE), an agency within the  
12 Department of Homeland Security.  
13

14 2. Petitioner is currently detained at Eloy Detention Center and is under  
15 the direct control of Respondents and their agents.  
16

17 3. This action arises under the Constitution of the United States and 8  
18 U.S.C. § 1101 et seq.

19 4. This Court has jurisdiction under 28 U.S.C. § 2241, Art. I § 9, cl. 2 of  
20 the United States Constitution, 28 U.S.C. § 1331, and the common law. This Court may  
21 grant relief pursuant to 28 U.S.C. § 2241, the Declaratory Judgment Act, 28 U.S.C. §  
22 2201 *et seq.*, and the All Writs Act, 28 U.S.C. § 1651.  
23

24 5. Congress has preserved judicial review of challenges to immigration  
25 detention. *See Jennings v. Rodriguez*, 583 U.S. 122, 130-131 (2018) (holding that 8  
26  
27  
28

1 U.S.C. §§ 1226(e) and 1252(b)(9) do not bar review of challenges to prolonged  
2 immigration detention).

3  
4 6. The Court must grant the petition for writ of habeas corpus or order  
5 Respondents to show cause “forthwith,” unless the petitioner is not entitled to relief. 28  
6 U.S.C. § 2243. If an order to show cause is issued, Respondents must file a return  
7 “within three days unless for good cause additional time, not exceeding twenty days, is  
8 allowed.” *Id.*


9  
10 7. The Court has inherent power to release the petitioner pending review  
11 of his petition. *See Martin v. Solem*, 801 F.2d 324, 329 (8th Cir. 1986).

### 12 VENUE

13  
14 8. Pursuant to *Braden v. 30th Judicial Circuit Court of Kentucky*, 410  
15 U.S. 484, 493- 500 (1973), venue lies in this Court, the federal judicial district in which  
16 Petitioner is currently is in custody.

17  
18 9. Venue is also properly in this Court pursuant to 18 U.S.C. § 1391(e)  
19 because Respondents are employees, officers, and agencies of the United States.

### 20 PARTIES

21  
22 10. Petitioner Leticia Lopez Penaloza was born on  in  
23 Michoacan, Mexico. Petitioner is currently detained by ICE at Eloy Detention Center.  
24 *See*, ICE Online Detainee Locator, filed herewith as Exhibit 3.

1           11.         Respondent Kristi Noem is the Secretary of the U.S. Department of  
2 Homeland Security (“DHS”). In this capacity, Respondent Noem is a legal custodian of  
3 Petitioner. Respondent Noem is sued in her official capacity.  
4

5           12.         Respondent DHS is a federal executive agency responsible for, among  
6 other things, enforcing federal immigration laws and overseeing lawful immigration to  
7 the United States. Respondent DHS is a legal custodian of Petitioner.  
8

9           13.         Respondent Todd M. Lyons is Acting Director and Senior Official  
10 Performing the Duties of the Director of U.S. Immigration and Customs Enforcement  
11 (“ICE”). Respondent Lyons is responsible for ICE’s policies, practices, and procedures,  
12 including those relating to the detention of immigrants during their removal procedures.  
13 Respondent Lyons is a legal custodian of Petitioner. Respondent Lyons is sued in his  
14 official capacity.  
15

16           14.         Respondent ICE is a federal law enforcement agency within DHS.  
17 Respondent ICE is responsible for the enforcement of immigration laws, including the  
18 detention and removal of immigrants. Respondent ICE is a legal custodian of Petitioner.  
19

20           15.         Respondent John Cantu is Field Office Director for ICE’s Enforcement  
21 and Removal Operation’s (“ERO”) Field Office. Respondent Cantu is a legal custodian  
22 of Petitioner and is sued in his official capacity.  
23

24           16.         Respondent Fred Figueroa is the Warden of the Eloy Detention Center.  
25 Respondent Figueroa is a legal custodian of Petitioner. Respondent Figueroa is sued in  
26 his official capacity.  
27  
28



1           25.       The length of time that a petitioner has been living in the United States  
2 is a constitutionally relevant consideration, because “once an alien enters the country,  
3 the legal circumstance changes, for the Due Process Clause applies to all ‘persons’  
4 within the United States, including aliens, whether their presence here is lawful,  
5 unlawful, temporary, or permanent.” *Zadvydas v. Davis*, 533 U.S. 678, 693 (2001). It  
6 is therefore reasonable to read these statutes “against [that] backdrop.” *See Hewitt v.*  
7 *United States*, 605 U.S. —, 145 S. Ct. 2165, 2173 (2025).

10           26.       Due process thus requires “adequate procedural protections” to ensure  
11 that the government’s asserted justification for a noncitizen’s physical confinement  
12 “outweighs the individual’s constitutionally protected interest in avoiding physical  
13 restraint.” *Zadvydas*, 533 U.S. at 690 (internal quotation marks omitted).

15           27.       In the immigration context, the Supreme Court has recognized only  
16 two valid purposes for civil detention: to mitigate the risks of danger to the community  
17 and to prevent flight. *Id.*; *Demore*, 538 U.S. at 528. The government may not detain a  
18 noncitizen based on any other justification.

20           28.       Congress has granted the Attorney General discretion to decide  
21 whether to detain or release certain noncitizens pending a removal decision. *See* 8 U.S.C.  
22 § 1226(a). The Attorney General has delegated that authority to IJs. 8 C.F.R. §§ 1003.19,  
23 1236.1.

24           29.       On July 8, 2025, DHS adopted a new policy on mandatory detention  
25 for noncitizens who have been residing in the United States. *See*, ICE Memo: Interim  
26  
27  
28

1 Guidance Regarding Detention Authority for Applications for Admission filed herewith  
2 as Exhibit 1.

3  
4 30. On September 5, 2025, the BIA entered the precedential decision  
5 *Matter of Yajure Hurtado*, 29 I&N Dec. 216 (B.I.A. 2025), filed herewith as Exhibit 2,  
6 which holds that all noncitizens who enter without inspection are “applicants for  
7 admission” under 8 U.S.C. § 1225(a) and therefore subject to mandatory detention under  
8 § 1225(b)(2), without regard for the length of time they have lived in the United States.

9  
10 31. The Ninth Circuit has held that § 1226(a) is the “default” detention  
11 statute for aliens in removal proceedings “[8 U.S.C. §1226(a) (“Subsection A”)] is the  
12 default detention statute for noncitizens in removal proceedings and applies to  
13 noncitizens “[e]xcept as provided in [Subsection C].” 8 U.S.C. § 1226(a).” *Avilez v.*  
14 *Garland*, 69 F. 4th 525, 529-530 (9th Cir. 2022). *Accord, Rodriguez Diaz v. Garland*,  
15 83 F. 4th 1177, 1179 (9th Cir. 2023); *Sarr v. Scott*, 765 F. Supp. 3d 1091, 1095 (WD  
16 Wash. 2025); *Prieto-Romero v. Clark*, 534 F.3d 1053, 1057 (9th Cir. 2008). *Casas-*  
17 *Castrillon v. DHS*, 535 F.3d 942 (9th Cir. 2008).

18  
19  
20 32. Almost every Federal District Court that has considered the issue has  
21 found that DHS’s interpretation defies the INA. In Arizona, the following decisions so  
22 find and collect the cases from other district courts around the country:

24  
25 a. 12/12/2025 Order granting habeas in *Gonzalez-Gonzalez v. Noem*, et al.,  
26 Case No. 25-cv-04478-DWL (D. Ariz 12-12-25)(The court declined to  
27 revisit the conclusion it reached in *Echevarria*).
- 28 b. 11/26/2025 Order granting habeas in *Luna-Gonzalez v. Noem*, et al., Case  
No. 25-cv-03794-PHX (D. Ariz 11-26-25)(The court rejected the

1 government's argument that the petitioner is an "arriving alien" subject to  
2 mandatory detention under § 1225 and agrees instead with the growing  
3 majority of courts that people like the petitioner—who were arrested  
4 inside the United States long after entering—are detained under § 1226(a),  
5 not § 1225.), gathering cases, filed with the Habeas Petition as Exhibit 7;

6 c. 11/24/25 Order granting habeas in *Padron-Carreron v. Noem*, et al., Case  
7 No. 25-cv-04204-PHX (D. Ariz. 11-25-25)("Respondents correctly  
8 acknowledge that their view still represents the minority position—in the  
9 weeks since the Court considered the issue in *Echevarria*, dozens of other  
10 courts have reached the same conclusion... [that] § 1226(a)'s application  
11 for the past three decades supports its application to noncitizens in  
12 petitioner's position"), gathering cases, filed with the Habeas Petition as  
13 Exhibit 8;

14 d. 11/18/2025 Order granting habeas in *Rodrigues da Silva v. Figueroa*, et  
15 al., Case No. 25-cv-04015-PHX (D. Ariz. 11-18-25)("dozens of other  
16 district courts have concluded individuals like Petitioner are subject to §  
17 1226 and not § 1225 and, therefore, are not subject to mandatory  
18 detention"), gathering cases, filed with the Habeas Petition as Exhibit 9;

19 e. 11/13/2025 Order granting habeas in *Perez Rodriguez v. Noem*, et al., Case  
20 No. 25-cv-03921-PHX (D. Ariz. 11/13/2025)("the vast majority of courts  
21 concluded individuals like Petitioner are subject to § 1226 and not § 1225  
22 and, therefore, are not subject to mandatory detention"), gathering cases,  
23 filed with the Habeas Petition as Exhibit 10

24 f. 11/6/25 Order granting habeas in *Gonzalez Rodriguez v. Bondi*, et al., Case  
25 No. 25-cv-03917-PHX (D. Ariz. 11-6-25)("dozens of other district courts  
26 have concluded individuals like Petitioner are subject to § 1226 and not §  
27 1225 and, therefore, are not subject to mandatory detention"), gathering  
28 cases, filed with the Habeas Petition as Exhibit 11

g. 11/6/2025 Order Granting Habeas in *Abrego-Zarate v. Noem, et al.*, Case  
No. 25-cv-03564-KML (D. Ariz. 11-6-25)("the great weigh of authority  
is that individuals like petitioner are not subject to mandatory detention.  
This court agrees with the majority view. For these reasons, the petition is

1 granted, and petitioner must receive a bond hearing without application of  
2 *Matter of Yajure Hurtado*, 29 I&N 216 (B.I.A. 2025.”), filed herewith as  
3 Exhibit 12.

4 h. 11/03/25 Order granting habeas petition in *Lopez-Cruz v. Noem, et al*, No.  
5 2:25-cv-03566-DJH--ASB (D. Ariz. 11/3/2025)(“dozens of other district  
6 courts have concluded individuals like Petitioner are subject to § 1226 and  
7 not § 1225 and, therefore, are not subject to mandatory detention. This  
8 Court agrees with this conclusion.”), filed herewith as Exhibit 13.

9 i. 10/22/2025 Order granting habeas in *Garcia-Rosales v. Noem, et al.*, No.  
10 2:25-cv-03391-SHD-DMF at page 2 (D. Ariz. Oct. 22, 2025)(“while  
11 Respondents point to two district court opinions adopting their  
12 interpretation of § 1225(b)(2)(A), myriad other district courts have  
13 reached the same conclusion as *Echevarria* and held individuals like  
14 Petitioner are not subject to mandatory detention under 1225(b)(2)(A)”),  
15 filed herewith as Exhibit 14.

16 j. 10/17/2025 Order granting habeas corpus in *Benitez-Cornejo v. Cantu, et*  
17 *al.*, No. 2:25-cv-03672 (D. Arizona Oct. 17, 2025)(“individuals like  
18 Petitioner are not “arriving aliens” subject to mandatory detention but,  
19 rather, are subject to the general removal statute, 8 U.S.C. § 1226(a)”),  
20 filed herewith as Exhibit 15.

21 k. 10/09/2025 Order granting habeas entered in *Hector Lopez-Melo v. Bondi,*  
22 *et. al.*, Case No. Case 2:25-cv-03394-DJH--JZB (D. Ariz.  
23 10/9/2025)(“petitioner, who had been present in the United States for  
24 years, was not an applicant for admission under 1225(b)(2)(A) or subject  
25 to mandatory detention”), filed herewith as Exhibit 16.

26 l. 10/07/2025 Order granting habeas corpus in *Bo Li v. Cantu, et al.*, No.  
27 CV-25-02989-PHX-SPL (D Arizona 10/07/2025)(“Respondents maintain  
28 he is subject to mandatory detention under 1225(b)(2). Again,  
Respondents are mistaken.”), filed herewith as Exhibit 17.

m. 10/3/2025 Order granting habeas corpus in *Echevarria v. Bondi, et al.*, No.  
2:25-cv-03252-PHX-DWL, 2025 WL 2821282 (D. Ariz. Oct. 3,

1 2025)(“Court agrees with the majority of courts that have concluded that  
2 § 1226(a), rather than § 1225(b)(2)(A), applies in this circumstance.”),  
3 filed herewith as Exhibit 18.

4 n. 08/11/2025 Magistrate’s Report and Recommendation in *Rocha Rosado*  
5 *v. Figueroa*, No. CV-25-02157-PHX-DLR 2025 WL 2349133 at \*10 (D.  
6 Ariz. Aug. 13, 2025)(Magistrate’s Report and Recommendation Adopted  
7 at 2025 WL 2349133)([t]he text of § 1226, the canons of statutory  
8 interpretation, this section's legislative history, and longstanding agency  
9 practice indicate that Rosado is subject to § 1226(a)’s ‘default’ rule for  
10 discretionary detention rather than § 1225’s mandatory detention  
11 requirement, and that the IJ erred by finding they did not have jurisdiction  
12 to consider Rosado's detention.”) *report and recommendation adopted sub*  
13 *nom.* 2025 WL 2349133 (D. Ariz. Aug. 13, 2025), filed herewith as  
14 Exhibit 19.

15 33. Petitioner has located only 6 cases holding to the contrary. In *Vargas*  
16 *Lopez v. Trump*, --F. Supp. 3d--, 2025 WL 2780351 (D. Neb. Sept. 30, 2025), the court  
17 held that Vargas Lopez failed to meet his burden to show that he falls under § 1226(a),  
18 so “his Petition fails regardless of the parties’ arguments about the scope of § 1225(b)  
19 and § 1226(a).” *Vargas Lopez v. Trump*, 2025 WL 2780351 at \*7 (emphasis added). In  
20 *Chavez v. Noem*, -- F. Supp. 3d --, 2025 WL 2730228 (S.D. Cal. Sept. 24, 2025), the  
21 court denied a temporary restraining order on the grounds that the petitioners had “not  
22 demonstrated serious questions about the application of Section 1225 to aliens present  
23 in the United States.” *Chavez v. Noem*, 2025 WL 2730228 at \*4. However, the court  
24 spent less than 2 pages analyzing the statutory language and caselaw before concluding  
25 that “Petitioners have not shown either a likelihood of success or serious questions going  
26 to the merits [therefore] we do not address the remaining Winter factors.” *Chavez v.*  
27

1 *Noem*, 2025 WL 2730228 at \*5. *Mejia Olalde v. Noem*, 2025 U.S. Dist. LEXIS 221830  
2 (E.D. Mo. Nov. 10, 2025) was concerned with whether the habeas petition had been  
3 properly filed in that court's jurisdiction and never reached the application of § 1225(b)  
4 to the petitioner. *Pipa-Aquise v. Bondi*, No. 25-1094, 2025 WL 2490657 (E.D. Va. Aug.  
5 5, 2025) and *Pena v. Hyde*, No. 25-11983, 2025 WL 2108913 (D. Mass. July 28, 2025)  
6 were each shorter than two pages long and neither contained any significant analysis.  
7 Lastly, in *Lauren-Ayala v. Noem*, No. 25-cv- 04425-KML--JFM (D. Ariz. 12/12/2025).  
8 the court did not reach the merits of the habeas claim or analyze the governing statute;  
9 instead, it dismissed the petition for lack of jurisdiction, concluding that, because  
10 petitioner failed to address the immigration court's alternative dangerousness finding, it  
11 could not order any effective relief. Thus, none of these cases are particularly instructive.  
12  
13  
14

15 34. In 1997, after Congress amended the INA through the Illegal  
16 Immigration Reform and Immigrant Responsibility Act of 1996 (IIRIRA), EOIR and  
17 the then-Immigration and Naturalization Service issued an interim rule to interpret and  
18 apply IIRIRA. Specifically, under the heading of "Apprehension, Custody, and  
19 Detention of Aliens," the agencies explained that:  
20  
21

22 Despite being applicants for admission, aliens who are  
23 present without having been admitted or paroled (formerly  
24 referred to as aliens who entered without inspection) ***will be eligible*** for bond and bond redetermination.

25 62 Fed. Reg. at 10323 (emphasis added). The agencies thus made clear that  
26 individuals who had entered without inspection ***were*** eligible for consideration for  
27  
28

1 bond and bond hearings before IJs under 8 U.S.C. § 1226 and its implementing  
2 regulations.

3  
4 35. Thus, for almost 30 years, all participants in the immigration system  
5 have understood that people arrested inside the United States generally fall within §  
6 1226 for detention purposes and are therefore required to receive a bond hearing upon  
7 request—even if they initially entered the country without permission. *See Martinez v.*  
8 *Hyde*, No. 25-11613, 2025 WL 2084238, at \*4 n.9 (D. Mass. July 24, 2025) (citing the  
9 United States Solicitor General’s representation to the Supreme Court at oral argument  
10 that “DHS’s long-standing interpretation has been that 1226(a) applies to those who  
11 have crossed the border between ports of entry and are shortly thereafter apprehended”).  
12

13  
14 36. Despite the overwhelming number of federal cases that have ruled  
15 against the government’s position, DHS and DOJ are continuing to systemically  
16 misclassify people and unlawfully deny them access to bond hearings and release on  
17 bond during the pendency of their immigration proceedings.  
18

19 **CLAIMS FOR RELIEF**  
20 **FIRST CLAIM FOR RELIEF**  
21 **Violation of Fifth Amendment – Substantive Due Process**

22 37. Petitioner realleges and incorporates herein the allegations contained  
23 in the preceding paragraphs of the petition as if fully set forth herein.  
24

25 38. The Due Process Clause of the Fifth Amendment forbids the  
26 government from depriving any “person” of liberty “without due process of law,”  
27 including noncitizens. U.S. Const. amend. V.  
28



**PRAYER FOR RELIEF**

**WHEREFORE** Petitioner Leticia Lopez Penaloza respectfully requests that the Court grant the following relief:

1. Assume jurisdiction over this matter;
2. Order Respondents not to transfer Petitioner out of this District during the pendency of these proceedings, to preserve jurisdiction;
3. Issue a Writ of Habeas Corpus pursuant to 28 U.S.C. § 2241 and order Respondents to immediately release Petitioner from custody or, in the alternative, order Respondents to provide Petitioner a bond hearing under 8 U.S.C. § 1226, and without regard to the holding of *Matter of Yajure Hurtado*, 29 I&N Dec. 216 (B.I.A. 2025), within three (3) business days;
4. Award Petitioner reasonable attorneys' fees and costs pursuant to the Equal Access to Justice Act, 28 U.S.C. § 2412; and
5. Grant any further relief the Court deems just and proper.
