7 January 20, 2026. Petitioner's status report omits any reference that a bond hearing was  
8 originally scheduled to be conducted on January 15, 2026 at 1:00 pm. See ECF No. 15.  
9 Petitioner's status report also omits any reference that Petitioner's Counsel specifically  
10 moved to continue the bond hearing to January 22, 2026 at 8:30 am. See ECF No. 15.
