This documents is for purpose of responding to the government's motion to reply and to the legal document provided by my deportation officer, Mr. Kurtis Reed, called " Kurtir Reed's statement."

FACTS:

1. Have been detained since 05/20/2025 at (NWIPC). As of the date of signing this document, I have completed a total of 279 days detained at this facility. I emphasize that on 08/29/2025, my case was closed and I was grated withholding of removal. Since that date, I have completed a total of 178 days detained, two days shy of completing six months in detention, the date on which the court considers a detention to be presumably reasonable.

2. On December 26,2025, I submitted a petition for habeas corpus to your office, in order to guarantee the fulfillment of my right to freedom.

3. On January 26,2026, I received a document from your office with the deadlines by which the government and I had to respond. The government had a deadline of 02/06/2026, and I had a

1 deadline of 02/11/2026, but it is important to mention to your honor that I only had the
2 government's reply information until one day before the deadline given by your office, making it
3 impossible for me to give a timely response to the documents that the government sent me.

4 4. On february 10,2026, I received the aforementioned documents, which I wish to oppose
5 for the following reasons:

6 **REGARDING THE STATEMENT OF MY DEPORTATION**
7 **OFFICER KURTIS REED.**

8 In point 17 of your statement, you spoke about the day "ERO" contacted me to show their
9 intention to deport me to Mexico. You also mention that I expressed fear of being deported to
10 that country, which is why they referred me to "USCIS" to obtain my credible fear interview
11 regarding Mexico. It is important to mention to your Honor that **THREE MONTHS** have passed
12 since the referral from (ERO) to (USCIS), without me being able to access my credible fear
13 interview. The foregoing constitutes a deliberate action by the government to keep me in
14 detention indefinitely without giving me the opportunity to defend my self.

15 **ABOUT THE GOVERNMENT'S RESPONSE**

16
17 Regarding the government's response in section four (Argument part A),the government
18 mentions that I have an open and pending case before the (BIA),this is important to mention
19 because all processes before the (BIA) are lengthy, which would put me in condition that would
20 affect my freedom as I would have to wait indefinitely for months until the (BIA) makes a final
21 decision in my case; which demonstrates a future indefinite detention as the court speaks of.

24 In light of the above, I request that your Honor disregard the arguments presented by the
25 government seeking to deny my habeas corpus petition, since if a favorable decision is not made

1 in my case, I could be detained indefinitely in this detention center. It has been demonstrate that
2 the government has deliberately delayed my process, which affects my right to liberty.

5 I also request that your Honor take into account that I am carrying out this entire process on my
6 own, and access to timely email or the means to better argue my request is extremely limited.
7 Therefore, I request that your Honor accept this response belatedly and, if possible, assign a
8 lawyer who can help me in this process.
