STATUS REPORT

In response to the Court's Minute Order dated February 23, 2026 (Dkt. 9), Federal Respondents submit the attached declaration of Detention Officer Robert Andron to describe the status of their attempts to remove Petitioner Roman Vasilchuk.

Federal Respondents previously reported that Petitioner's travel document request to Ukraine was about to be submitted to ERO headquarters for supervisory review (Dkt. 8, ¶ 18); it has now been sent from headquarters to the Department of State for final approval. Andron Decl., ¶ 6. ERO also attempted to have Petitioner complete a travel document request to Moldova, which Petitioner refused to sign. Andron Decl., ¶ 7.

Petitioner remains detained at the Northwest ICE Processing Center.
