Amended habeas for case # 26-CV-37

I was Detained on 12/11/2023, I was picked up from Shanno Wisconsin County Jail. I was on a 48 hour hold from Immigration. After 48 hours 10 minutes they came to pick me up. At the 48 hour mark I should have been Released from custody and had the right to turn my self in. They never showed me a warrant Judicial or other wise when I was detained by ICE. Upon arrival in Milwaukee the ICE Officer Reversed my supervision with letter included in packet I was never allowed to proceed with fighting my case or speaking with a Judge about that which violates my de poracion. I have been checking in with ICE every time I was supposed to since 2008, and only missed one check in was upon trying to contact ICE to be released I wasnt able to because there is no number to call.

After my ~~was~~ supervision was Reversed I was taken to Dodge County Jail where I had asked ICE to see a Judge and was told I do not have the right to see a Judge also included in packet, after I wrote my first habeas letter I got the papers for the writ and sent that to the court I was moved to Miami correction facility where they have Bullied me in to trying to

as you can see by their using
my name Charles Johannes and
mixing my brothers name Daniel Christian
Muller's name to try and deport me.

I have been in the USA since
11/23/93. they have gotten other papers
to determine my citizen ship status at
South Africa which also demand return to
me. The Act 58 of 1998 was made
effective 10/1/98 for the citizenship act of
South Africa and I had been out of the
country for two years at that point when
will be included in package.

As for the hard ship it is causing my
wife and kids. I was the main
provider of income for the house and my
wife is forced to go to work she
barely makes enough to cover bills let
alone pay a babysitter to watch our kids
all 3 of my children have extra needs
and all go to counseling. I ask for
~~my case~~ court to release me from detention
so I can help my wife and children,
so I can provide for my family,
and for myself so while I work towards
negotiating the proper procedures with
immigration to obtain proper documentation.

I came to this country when I was

South Africa, I don't speak the language.

I was a child when the witness at Remand/Deportation was put in place. I had no custody in the matter. I was 10 years old. I have no schooling in South Africa, and Bism White was sending American A as a death sentence to send me there. I have been here 33 years and have no true connections in South Africa. I have called the South African Embassy in Washington D.C. and asked them for Denial my travel documents because it don't exist there.

I would also like to add that I am currently at also with legal mail or posts return to sender on envelopes and does not give it to inmates as in my case.

When it comes to Medical Requests it takes and less than a week to three weeks for you are seen, and the proof of that just look up the deaths at Miami Correction Facility.

I'd please ask the Court to Release me back to my family and allow my to get back to work. I still have my ID badge in WDCOS Bin. I just need to be released so I can get the papers and go through the process to get my ID badge as the only contact.
