Petition for a writ of Habeas corpus pursuant to 28 U.S.C /2241

1. Introduction

I, Laith Nidal Abdel Raouf Omar , file this petition prose . I assert that my contined Detention by ICE has exceded the presumptively reasonable , six-months period established in zadvydas v. Davis , 533U.S 678 (200), and is now constitutionaly impermissible .

2. statement of facts .

Background: I'm a native and citizen of jordan , I've no criminal record in the U.S and possess a jordanian "non-conviction certificate" Proving my good conduct .

3. Detention : I entered U.S costady on December , 17, 2024 via the CBPone program and have been detained in differents ICE costadies .

Removal order : on june 2 , 2025 an immigration judge ordered my removal to jordan . The order became final on that date .

4. Duration : as of December 27 , 2025 I've been detained post -removal -order for over six months (200 days) .

5. cooperation : I've fully cooperated, possess a valid jordanian passport , and never refused to sign a travel document.

6. Government failure to remove :

ICE schaduled my deportation flight for november 11 , 2025 on november 4 , 2025 the U.S court of appeals case no. 25-60562 denied my stay of removal . Despite legal authority and my valid passport , ICE failed to remove me because the government cancelled the flight .

7. Legal Argument

-Zadvydas violation : the supreme court held that detention post-removal order is reasonable for only six months . Beyond this , if there is no "significant likelihood of removal in the reasonably foreseeable future" the government must release the alien .

8. No likelihood of Removal:the six months period has expired . The government failure to deporte me on november 11, 2025 despite having a flight and my passport , shows they cannot excute removal in the foreseeble future.

9. No risk : I'm not a flight risk or danger , as evidenced by my clean U.S record and Jordanian certificate .

10. Prayer for relief:

Assume Jurisdiction

Order my immediate release under an order of supervision .

Grant any other just relief .
