DECLARATION OF SUPERVISORY
DETENTION AND DEPORTATION
OFFICER BRETT BOOTH

I, BRETT BOOTH pursuant to 28 U.S.C. § 1746, hereby declare as follows:

1. I am a Supervisory Detention and Deportation Officer ("SDDO"), employed by the United States Department of Homeland Security ("DHS"), United States Immigration and Customs Enforcement ("ICE"), Office of Enforcement and Removal Operations ("ERO"). I am currently assigned to the ERO office at the Northwest ICE Processing Center ("NWIPC") in Tacoma, Washington, under the ERO Seattle Field Office. My current duties include, among other tasks, to review and process cases for noncitizens detained in ICE custody through the entirety of the immigration case; this includes preparing for facilitating the removal of noncitizens subject to final orders of removal.

1 2. I am familiar with the case of G.R.R., agency file A  I make this declaration
2 based upon my personal and professional knowledge, information obtained from other individuals
3 employed by ICE, and information obtained from various records and systems maintained by ICE in
4 the regular course of business. I provide this declaration based on the best of my knowledge,
5 information, belief, and reasonable inquiry in the above-captioned case.

6 3. The Court's ordered dated February 12, 2026 requires the government to release the
7 Petitioner from custody immediately under the terms of his prior conditional release. The Petitioner
8 was previously released upon posting a delivery bond in the amount of \$10,000.

9 4. On October 18, 2023 and Immigration Judge granted a bond in the amount of \$10,000 with
10 any conditions set by ICE.

11 5. On October 18, 2023 the Petitioner posted the \$10,000 bond and he was released on GPS
12 supervision.

13 6. On October 1, 2025 the Petitioner was taken back into ICE custody. His \$10,000 delivery
14 bond was cancelled on October 1, 2025.

15 7. ICE has updated its systems so that the Petitioner can re-post the \$10,000 bond. Once the
16 bond is posted he will be released from custody on the same GPS supervision.

17 I declare under penalty of perjury that the foregoing declaration is true and correct to the
18 best of my knowledge and belief.
