PETITIONER

Federal Respondents provide NOTICE to the Court that on February 26, 2026, an Immigration Judge in Tacoma, Washington ordered Petitioner Yorbys Rodriguez Chirinos' removal from the United States to Venezuela. Petitioner waived his right to appeal the Immigration Judge's decision, and as such, his removal order became administratively final on the date of its issuance. *See* 8 C.F.R. § 1241.1(b). Immigration and Customs Enforcement ("ICE") has informed the undersigned of its intent to remove Petitioner from the United States. Therefore, Federal Respondents provide this Court notice of Petitioner's forthcoming removal in accordance with the Court's February 2, 2026, scheduling order. *See* Dkt. 4 ¶ 3.
