

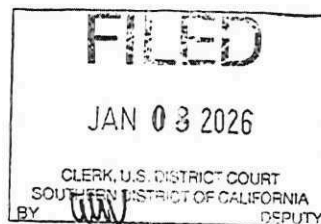

GROUND ONE: I was taken into custody leaving court by ICE officers
and was not given a reason for why I was pulled
over

I was pulled over by 3 cars with no type of identification.
The officers were all covered up and did not show any type
of warrant for my arrest. The officers also used excessive
use of force by pulling me out and even opened my driver
side door after getting me out they still went and
searched my car.

GROUND TWO: I also have an asylum case pending and being inside the detention center it makes it difficult to gather information to support my case.
