**STATUS REPORT**

---

Pursuant to the Court's February 12, 2026, Order, Respondents file this status report to the Court. See ECF No. 14. The Court's Order required that a bond hearing be held for Petitioner within 7 days. See *id.* at 3. The Order further stated that Respondents must "file a status report within FIVE DAYS of Petitioner's custody hearing, stating whether he has been granted bond, and, if his request for bond was denied, the reasons for that denial." *Id.*

On February 18, 2026, a bond hearing before an immigration judge was held for Petitioner pursuant to this Court's February 12, 2026, Order. At the bond hearing, the

immigration judge granted bond, ordering Petitioner released from custody under a bond of \$5,000.00.

As to Petitioner's Notice filed on February 20, 2026, Respondents confirm that, on Saturday, February 21, 2026, Respondents removed Petitioner's ankle monitor. See ECF No. 15 at 4. In addition, Respondents state that Petitioner was disenrolled from the Alternatives to Detention program and is no longer scheduled for any check-in with U.S. Immigration and Customs Enforcement. *See id.*
