**PETITIONER'S NOTICE
OF SUPPLEMENTAL
FACTS**

1 Petitioner hereby submits this Notice of Supplemental Facts for this Court's
2 attention.
3

4 On March 6, 2026, Petitioner had his Individual Hearing at the Tacoma
5 Immigration Court on his application for Cancellation of Removal for Certain
6 Nonpermanent Residents. The hearing was extended past his 10:30 stop time and
7 the merits hearing was completed.

9 The Immigration Judge denied Petitioner's application for Cancellation of
10 Removal for Certain Nonpermanent Residents at the conclusion of the Individual
11 Hearing stating that he did not meet his burden in proving that his Lawful
12 Permanent Resident wife would suffer "exceptional and extremely unusual
13 hardship" if he were deported to Mexico. The IJ also denied on discretion stating
14 that she would have denied his application because of his TikTok post, even if he
15 had established "exceptional and extremely unusual hardship".

19 Petitioner stated his intent to file an appeal and reserved appeal so that he
20 can appeal the decision to the Board of Immigration Appeals. The EOIR Court
21 order is attached to this Notice as Petitioner's Exhibit 14. The Notice of Appeal to
22 the BIA is virtually certain to be filed next week. This IJ order is not a final order
23 of deportation.
