**AFFIDAVIT OF**  
**KIRA KELLEY**

I, Kira Aakre Kelley, pursuant to 28 U.S.C. § 1746, declare as follows:

1. I represent Leiner Leonel Guillas Guaman in this proceeding. In the evening of February 12, 2026, I spoke with his romantic partner to confirm my understanding of Mr. Guillas Guaman's immigration history, which is that he was not in removal proceedings, he did not have a Notice to Appear prior to the detention that is the subject of this case, and that he had entered without inspection when he arrived in the United States.
2. His partner confirmed to me that he did not have a Notice to Appear, any open proceedings in immigration court, or an A number, at the time of his arrest.
3. Mr. Leiner Leonel Guillas Guaman was provided an A number after his arrest, which he was able to provide to his partner and I.
4. I tested this A number to make sure it was correct by entering it in the ICE Detainee Locator, <https://locator.ice.gov/>, which yielded the following result:
