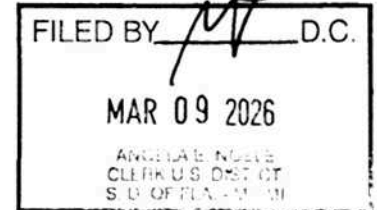

IMMEDIATELY RELEASE.

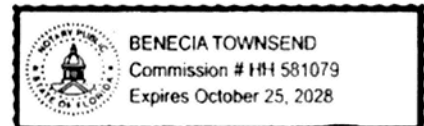
ALSO THE IMMIGRATION COURT GIVED ICE AND GOVERNMENT TO RESPOND
