STATUS REPORT

Respondents submit this status report in compliance with the Court's February 18, 2026, Order (ECF No. 11). In the Order, the Court required Respondents to: (1) provide Petitioner with a bond hearing within seven days of the date of the Order; and (2) file a status report within ten days. *Id.* at 7. The status report is to "include if and when the bond hearing occurred, if bond was granted or denied, and if bond was denied, the reasons for the denial." *Id.*

On February 24, 2026, the Immigration Judge (IJ) held a bond hearing for Petitioner. *See* Ex. 1, Order of the Immigration Judge at 1. The IJ granted bond in the amount of \$5,000 “with the option for any other conditions deemed appropriate by the [Department of Homeland Security]” to “mitigate concerns that [Petitioner] may abscond.” *Id.* at 2.

Undersigned counsel is informed that as of the date of this status report, Petitioner has posted bond and been released consistent with the IJ’s order.
