FINAL JOINT STATUS REPORT

Petitioner and Respondents, by and through counsel, submit this Final Joint Status Report in accordance with the Court's February 18, 2026 Order (ECF No. 10) and state:

1. In the Court's February 18, 2026 Order, the Court ordered that Petitioner was detained and must be provided a bond hearing under 8 U.S.C. § 1226(a) and retained jurisdiction to enforce compliance with this Order.

2. Petitioner filed a Motion for a Bond hearing (custody redetermination) with the Immigration Court, which was granted.

3. On February 27, 2026, Petitioner had a Bond Hearing, and his request for bond was granted; he was ordered released subject to a bond of \$8,000.00 and any other conditions deemed appropriate by the DHS, to further mitigate concerns that the Respondent may abscond. *See attached* Order of the Immigration Judge.

4. The Court's order of February 18, 2026 has been satisfied.

5. Respondents ask that no further status reports be required, and this case be closed. Petitioner has no objection.
