Re: information about my petition for a Writ of Habeas Corpus.

I am writing to ask you if the petition filed by Jennifer about a month ago has been withdrawn or is it still active?

Here I am sending you some information so I can help you understand why I'm reaching out to you instead of Jennifer the attorney that file the petition.

- I already wrote Jennifer a few weeks ago requesting to withdraw the petition.
- My employer hired Jennifer.
- I have not signed any documents for Jennifer.
- I can only file the petition after 6 months have pass in I.C.E. detention.
- Jennifer filed the petition about 3 weeks before the completion of 6 months.
- I do not want to file before my detention reaches 6 months, I only want to file after I complete 6 months in ice detention.
- My detention becomes unlawful after 6 months and I will be able to file a petition.
- I have been in I.C.E. detention since 09/17/2025 until present and my final order of removal became final 12/14/2012.
- I did not speak with Jennifer before she filed the petition.

I'm only sending you that information so you can see my situation. Also I think my employer made a go fund me account asking for money for my medical bills because I have been sent to the hospital at least twice here while in I.C.E. detention. I do not want to be part of fraud, the facility G.E.O or the government cover my medical expenses while in detention and my brother is working on paying the bill University Hospital in San Antonio sent me a week or two ago. I was in the hospital about 3 weeks ago and someone called the hospital asking for something related to my medical record. The medical personnel were worried because the person identified it self as "my lawyer" and the people that work at the hospital know that attorneys know beforehand that they need a written permission from the client to access medical records. At this moment I do not trust speaking with my employer or Jennifer because I don't want them to get me in more trouble. Also if my employer is posting online that I.C.E. is mistreating me, those posts can affect my immigration Process negatively. I did not reach out to her to request her to do that. I have not received paperwork or notices from the petition that has been filed. If you could kindly send me the information I am requesting from you I would greatly appreciate it. I only have one question.

The petition filed by Jennifer, is it withdrawn or is it still active?
