**PETITIONER'S STATUS REPORT**

Petitioner, JOSE MILLAN OLIVAS, by and through undersigned counsel, respectfully submits this Status Report in response to the Court's Order, dated April 2, 2026, at ECF No. 21.

On April 2, 2026, this Court granted Olivas's Motion to Enforce. ECF No. 21. In that Order, the Court ordered 1) Olivas's immediate release and 2) that, on or before April 3, 2026, Respondents confirm in writing that Olivas had been released from custody. ECF No. 21.

As of the date of this filing, Respondents have not submitted the required status report. Accordingly, Olivas files this Status Report to advise the Court that, although the Court ordered Olivas's immediate release on April 2, 2026, he was not released until April 3, 2026. *See ICE Form I-830E, Notice to EOIR: Alien Address, dated April 3, 2026, attached hereto as Attachment A.*

On April 2, 2026, undersigned counsel contacted counsel for Respondents regarding the delay in Olivas's release. In response, Respondents' counsel advised that a supervisor had been notified to ensure that nothing fell through the cracks with respect to Olivas's release. Undersigned counsel received no further update regarding the delay, and Respondents have not submitted the written status report required by the Court's Order.
