MOTION TO EXPEDITE CONSIDERATION OF HABEAS PETITION

Petitioner, by and through counsel, motions this Honorable Court to expedite consideration of his Habeas Petition and avers the following in support of this motion:

- 1) That Petitioner filed a Petition for Writ of Habeas Corpus 18 days ago, on February 26, 2026. *See* Dkt. 1.
- 2) That this Court issued an Order instructing Respondents not to transfer Petitioner out of this Court's jurisdiction on February 26, 2026.
- 3) That Respondents' counsel from the U.S. Attorney's office has entered an appearance in this matter on February 27, 2026. *See* Dkt 3.
- 4) That Respondents filed an Answer to the Habeas Petition on February 27, 2026. *See* Dkt. 4.

- 5) That in his Petition, Petitioner avers serious and constitutional matters pertaining to the alleged unlawful deprivation of his liberty interests. *See* Dkt. 1.
- 6) That Petitioner is the father of a 9 year old U.S. citizen disabled child who has been separated from him for 18 days.
- 7) To date, no order has been issued on the Petition and Petitioner remains in detention at the Philadelphia Federal Detention Center without the possibility of release absent this Honorable Court's intervention.

WHEREFORE, Petitioner respectfully motions this Honorable Court to expedite the decision regarding his Habeas Petition.
