I told them that I was afraid to return to Honduras because of fear of persecution based ~~\_\_\_\_\_~~ was released from detention and given a Notice to Appear. No expedited removal order was enforced.

I filed an application for asylum with USCIS on September 5, 2024 and that is still pending. I was directed to report to ICE on February 27, 2026 at which time I was detained. I am being hold in the Baltimore holding cell.
