I am being held in a cell with forty women. There is only one bathroom for all of us and no shower. We do not have toiletries including soap. I am wearing the same clothes since the day I was detained. There are not enough cots for us to sleep on so we have to sleep on the floor or leaning against one another. I have diabetes but am not getting insulin and I can only have one of the three pills I am supposed to take each day. I am not getting the medication prescribed for my high blood pressure.
